OCSO CHARGES FWB COUPLE WITH CHILD NEGLECT

The Okaloosa County Sheriff's Office has charged a Fort Walton Beach couple with child neglect after finding three youngsters in a filthy home on Colton Way that had no running water and evidence of drug use.

Deputies say the children were dirty and there was very little food in the home. They also discovered marijuana on a video game box, along with one meth pipe next to a bag of potato chips in a kitchen cabinet and another in a box next to the kitchen sink.

26-year old Anthony Sosebee of 2000 Colton Way is charged with child neglect, possession of methamphetamine, and possession of drug paraphernalia.

24-year old Amanda Kaye Clayton of the same address is charged with child neglect.

On 4/1/2014 at approximately 1915 hours, at 2000 Colton Way, Fort Walton Beach FL, it was discovered the defendant, Anthony Sosebee committed the offense of child neglect and possession of drug paraphernalia and possession of methamphetamine, to wit;								
On the above date and time, the defendant and his girlfriend, Amanda Clayton, were reported by an anonymous caller to Department of Children and Families in reference to neglect of Addition. The allegation included drug use, a filthy home, and general lack of care of the children.

allegation. Upon arrival, Amanda came outside and spoke briefly to us. She told us Anthony was not home and excused herself and went inside. About two minutes later, she, and the defendant emerged and asked about the allegation. Two of the children came to the door with Amanda. From my position about 10 feet away, I could see the children looked dirty.

Remeeka asked if we could come inside and take a look at the home. Anthony agreed and allowed us inside. The defendant said "come on in, look around, we have nothing to hide". I walked into the house and immediately saw a white male passed out on the couch with a bottle of whiskey under his right leg. I went down the hallway and Anthony said "hold on man, let me go with you". Anthony walked with me and showed me a bedroom that had children's toys spread around the floor, and what looked like a toddler bed without a mattress. The bed was clearly dirty. As we continued down the hall, Anthony passed two doors. I asked what was in them and if I could look. Anthony told me they were bathrooms. I opened the door and was overwhelmed by the smell of feces. From the hallway, I could see the toilet was full of fecal matter. I looked in the other room and found a second bathroom that also contained a toilet full of feces.

A continued walk thru of the house was conducted and I found a video game case on the refrigerator in the kitchen that had approximately 2 grams of marijuana on it. Dishes were piled in the sink. There were no places for the children or the adults to sleep. There was very little food in the house.

Later, I was in the kitchen and could still smell marijuana near the sink. I saw a pink box next to the sink on the window sill. I opened the box and found a metal pipe, a glass pipe, and a light bulb that had been turned into a methamphetamine pipe. The methamphetamine pipe was swabbed and tested positive for the presence of methamphetamine in a presumptive field test.

Post miranda, the defendant admitted the contents of the box were his.

Based on the condition of the home to include the lack of running water, open fecal matter, uncleanliness of the children, presence and accessibility of alcohol and drugs in the house, it was clear there was a failure by the caregiver (Anthony Sosebee) to provide the children with the care, supervision, and services necessary to maintain their physical and mental health. I placed Anthony Sosebee under arrest for Child Neglect pursuant to F.S.S. 827.03.2d. In a post miranda interview, Anthony admitted the pipes were his. Anthony was charged with possession of drug paraphernalia pursuant to F.S.S. 893.147.1. and possession of methamphetamine pursuant to F.S.S. 893.13.6a.

This offense occurred in Okaloosa County, Florida where I am a sworn law enforcement officer.
