OCSO SEIZES A POUND OF HIGH GRADE MARIJUANA, ARRESTS ONE





Agents of the Okaloosa County Multi-Agency Drug Task Force executed a narcotics search warrant today at 21 Chatelaine Circle in Fort Walton Beach.

They seized approximately one pound of high-grade marijuana that was packaged for sale, along with drug paraphernalia and cash.

As a result of the investigation, 32-year old Christopher Lynn Pritchett is charged with Possession of Marijuana with Intent to Distribute and Possession of Drug Paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 27, 2014, a lawful narcotics search warrant was obtained for the residence located at 21 Chatelaine Circle SE, Fort Walton Beach, Okaloosa County, Florida. This narcotics search warrant was read and signed by the Honorable John Brown. The aforementioned address has been identified as belonging to Christopher Lynn Pritchett (defendant).

On April, 03, 2014, your Affiant along with members of the Okaloosa County Multi Agency Drug Task Force,

executed said narcotics search warrant at the aforementioned address. During the execution, Pritchett was located and detained inside the residence.

During a search of the residence agents of the Drug Task Force located the following contraband:

- -Approximately one (1) pound of marijuana, which field tested positive for the presence of THC. This marijuana was packaged in a manner consistent with the distribution of marijuana. The packaging consisted of primarily gram bags and ounce bags of marijuana.
- -A digital scale with marijuana particles, which tested positive for the presence of THC.

During a post Miranda interview, Pritchett made the following statements to your Affiant:

- -Pritchett stated he does, on occasion, sell marijuana to few people.
- -Pritchett stated he sells approximately one to two gram quantities to people and he does so on his own.
- -Pritchett claimed ownership of all the marijuana and paraphernalia inside the residence.

Based on the above, your Affiant has probable cause to believe that Christopher Lynn Pritchett did violate Florida State Statutes 893.13.1a2: possession with intent to distribute marijuana; and 893.147: possession of paraphernalia.
