## PROSTITUTION STING NETS SIX ARRESTS ON CHARGES RANGING FROM PROSTITUTION TO DRUG POSSESSION

The Okaloosa County Multi-Agency Drug Task Force conducted a prostitution sting on August 14<sup>th</sup>, leading to six arrests on various charges.

The operation was aimed at females posting solicitation advertisements on Backpage.com.

Utilizing an undercover officer, females were contacted to meet at a location within Okaloosa County. Once on scene, the females solicited sex and/or a sex act for money.

Those charged with solicitation of prostitution are 27-year old Christy Ann Wages of Laurel Mississippi, 22-year old Hailey N. Williams of Milton, and 25-year old Lisa Duke of Fort Walton Beach. Duke is also charged with possession of drug paraphernalia.

In addition, three other arrests were made in conjunction with the sting: 31-year old Julie MacLennan of Freeport is charged with three counts of possession of a controlled substance, 25-year old Violet MacLennan of Freeport is charged with four counts of possession of a controlled substance and possession of drug paraphernalia, and 18-year old Nicholas Collins of Fort Walton Beach is charged with possession of marijuana over 20 grams and possession of drug paraphernalia.

Aspects of this investigation are ongoing.

On 08/14/14, the Okaloosa County Sheriff's Office Drug Task Force conducted a sting operation targeting call girl prostitutes advertising on internet websites. The Drug Task Force utilized an undercover officer (UC) to contact the prostitutes via the number provided on the prostitute's web page.

The UC contacted an advertisement for "Chelsa" (with a listed number on Backpage.com listed under the escorts column. The female agreed to meet the UC at the UC's hotel room located within the south end of Okaloosa County.

At approximately 1910hrs the defendant, Christy Wages, arrived at the UC's hotel room and agreed to exchange "safe" sex for \$60.00.

During a post Miranda interview the defendant admitted she intended on having intercourse with the UC in exchange for \$60.00. She admitted she had just come from an "appointment" where she exchanged oral sex and intercourse for \$100.00 prior to soliciting the UC. She stated she had been advertising on Backpage.com for approximately 6-7 years.

This is in violation of F.S.S. 794.07 Solicitation for prostitution. This violation occurred in Okaloosa County where I am a law enforcement officer.

Approximately one hour later a white Mercedes was observed entering the parking lot of the hotel which was occupied by a white male and a white female. Shortly thereafter the undercover investigator received a phone call from phone number (850)////at which point the female was advised to come to room 206. After making contact with the undercover investigator, "Noma" advised that she would do everything for \$200.00. The undercover asked "Noma" if she would do "anal" and "Noma" agreed to have anal intercourse. "Noma" was then detained and immediately advised of her Miranda rights and was identified as Lisa M. Duke.

Post Miranda, Duke advised that she engages in prostitution because she has no where to stay and added that she normally just takes the money and leaves. Duke stated she uses the money to buy food, cigarettes, and hotel rooms. When asked about how many calls she usually takes Duke stated "4 or 5" then stated "less than 10." Duke also identified her phone number as (850)///// but stated that she left that phone in her boyfriends car which is why she called from a different number and why she was in possession of the phone with the secondary phone number.

Search incident to arrest revealed several drug paraphernalia items in Duke's purse. Several corner baggies were located containing cocaine residue which field tested positive for cocaine. A clear lid was also located which contained a white residue which field tested positive for heroin.

Based on the aforementioned information I have reason to believe that the Defendant, Lisa M. Duke, did violate F.S.S.

On August 14, 2014, members of the Okaloosa County Multi-Agency Drug Task Force, in conjunction with the Florida									

Department of Law Enforcement, conducted an investigation into prostitution possibly occurring within Okaloosa County Florida. This investigation occurred at the Sheraton Four Points hotel located at 1325 Miracle Strip Parkway, Fort Walton Beach, Okaloosa County, Florida.

During this investigation a meeting was arranged with a female identifying herself as "Noma" who agreed to meet the undercover investigator at the Sheraton Four Points hotel. Surveillance units observed an older model Mercedes enter the parking lot which was occupied by a white male subject and a white female subject. The female subject exited the vehicle at which point the Mercedes departed the scene and was followed by surveillance units. During the investigation, the female, which was observed exiting the Mercedes, was confirmed to be "Noma" and was subsequently taken into custody for solicitation of prostitution.

Sgt. Ron Kimble made contact with the driver of the Mercedes at 656 S. Santa Rosa Boulevard, Fort Walton Beach, Florida, for the ongoing prostitution investigation. The subject, Nicholas A. Collins, was advised of his Miranda rights by Sgt. Kimble and exercised his right to have an attorney present. During the investigation D/S Derek York conducted a
