## COUNTERFEIT MONEY DOESN'T PASS MUSTER FOR CASHIER AT LOCAL MCDONALD'S

A worker at a Shalimar McDonald's spotted what appeared to be fake money last night when two teens tried to pay for their order at the drivethrough window.

He contacted the Okaloosa County Sheriff's Office after noticing the twenty dollar bill handed over for the approximately six dollar order appeared to be counterfeit. When deputies arrived, the two teens in the Pontiac van took off. One was spotted throwing something out of the passenger side window. A check of that area revealed two balled up counterfeit \$20 bills.

The money used at the McDonald's and the money thrown from the car had the exact same serial numbers.

Deputies pulled over the van and have charged 19-year old Matthew Teems of Fort Walton Beach and 17-year old Jonathan Ruiz of Shalimar with fraud, uttering a false bill.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 12/22/2014 at approximately 2200 hours, I responded to McDonald's restaurant, 1189 Eglin Parkway, Shalimar, FL, in reference to a forgery. I received a sworn verbal and written statement from witness, Christopher Robinson. Robinson advised two males later identified as codefendant, Matthew Teems, and defendant, Jonathan Ruiz, came through the restaurant drive through. The defendant gave him a 20 dollar bill. Upon inspecting the currency, it was determined the bill was fake. When law enforcement arrived on scene the defendant drove away in a 2002 Pontiac van.

Witness, Karl Halder, provided an affidavit of complaint on the behalf of the restaurant and a sworn verbal statement. Halder advised Robinson was given a fake 20 dollar bill for an order that cost \$5.71. Halder confirmed the bill was fake due to it not having any watermarks or security features. Upon law enforcement arrival the defendant and codefendant fled in a van.

The defendant and codefendant were stopped in the vehicle at 7th Ave and 3rd St, Shalimar, FL, where the codefendant was observed throwing something out of the passenger side of the vehicle. It was later identified the codefendant threw 2 counterfeit 20 dollar bills.

Post Miranda the defendant provided a statement advising he drove the codefendant to McDonald's. The codefendant gave him a 20 dollar bill for his order which the defendant gave to the cashier. The defendant advised he figured out the bill was fake and attempted to pay the cashier with actual money.

Robinson advised at no time did the defendant attempt to give him any other money, other than the forged 20 dollar bill.

It was identified the bill used at McDonald's and the bills the codefendant had thrown from the vehicle had the same serial number JF77582244D.

Based on the physical and testimonial evidence I have reason to and do believe the defendant, Jonathan Ruiz, was in violation of Florida State Statute 831.09 Fraud Utter False Bill. This incident occurred in Okaloosa County where I
