OCSO ARRESTS TWO IN COUNTERFEITING RING MORE ARRESTS EXPECTED

The Okaloosa County Sheriff's Office has charged two Fort Walton Beach residents in connection with a counterfeiting operation targeting multiple retailers and restaurants throughout Okaloosa County since January 1st.

The OCSO has received nearly two dozen counterfeit complaints since the beginning of the year.

An investigation revealed that 33-year old Shawn Lee Morse and 25-year old Meghan Leann Park of 108 Monahan Drive were making and issuing counterfeit money. A search warrant at the Monahan Drive address February 7th turned up uncut counterfeit bills ranging from ones to twenties, loose counterfeit bills,

marijuana and drug paraphernalia. Morse told investigators he was providing the counterfeit money to individuals in exchange for methamphetamine.

The OCSO is being assisted in the ongoing investigation by the U.S. Secret Service and additional arrests are expected.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

The Okaloosa County Sheriff's Office has received approximately 23 counterfeit complaints at multiple retailers and restaurants throughout Okaloosa County from January 1, 2014 to 5 February 2014.

On 6 February 2014, a documented confidential informant provided information to Okaloosa County Investigators that the defendant Shawn Lee Morse and co-defendant Meghan Leann Park were manufacturing and issuing counterfeit money.

The informant stated that he/she had received counterfeit bills from Morse and Parks while located inside their residence located at 108 Monahon Drive, apartment #3, Fort Walton Beach, Florida. The informant added that Morse and Park that while inside the residence he/she witnessed Megan Park cutting the counterfeit bills from their template. The informant was then shown by Shawn Parks how the counterfeit money was manufactured.

The same informant further stated that the defendants provide counterfeit money to methamphetamine customers/uses in exchange for green dot money cards. The green dot cards were exchanged for Methamphetamine and/or legitimate U.S. Currency. The informant stated that he/she has witnessed Morse and Park purchase paper and a HP 60 series printer ink cartridge either on 2 or 3 February 2014 at Walmart for the purchases of printing additional counterfeit currency. The informant added that the Multi-function printer machine being used to create the counterfeit money was brown in color.

On 7 February 2014, members of the Okaloosa County Sheriff's Office Criminal Investigations Division executed a search warrant at 108 Monahan Drive, Apartment C, Fort Walton Beach, Florida, the residence belonging to defendant and Co-defendant Meghan Leann Park.

During a search of the residence deputies located uncut counterfeit \$1, \$5, \$10, \$20, and \$100 bills, loose counterfeit bills, 21 grams of Marijuana, drug paraphernalia, and a brown HP multi-function printer.

During a post Miranda interview Park admitted they went to Walmart, purchased an 60 series ink cartridge in order to print counterfeit money. Park further stated that she and Morse produced counterfeit currency then benefited from passing said counterfeit currency in exchange for approximately \$200-300 cash money.

During a post Miranda interview the defendant, Shawn Morse admitted he used the printer located by deputies inside the residence to copy U.S. currency and print counterfeit bills in denominations ranging from \$1 and \$100. The defendant explained in detail the process he used to copy the money on the multi-function printer. Shawn Morse stated that he provide counterfeit money to individuals in exchange for methamphetamines.
