Based on a sworn affidavit of complaint signed by victim, Bobby Jean Butterworth along with witness statements, digital evidence, and a criminal investigation stating to wit:

On February 26, 2014 at approximately 1839 hrs, the Okaloosa County Sheriff's Office received a 911 call from victim, Bobby Jean Butterworth concerning a carjacking. Information was relayed via dispatch to responding units which included a vehicle description and suspect description. Per Bobby Butterworth, at approximately 1815 hrs, she traveled to

the Dollar General store located on Highway 4 Baker, Florida in her personal vehicle. Ms. Butterworth parked her vehicle, a light colored 2010 Kia Soul bearing Florida tag C219XX on the North side of the store. When Ms. Butterworth exited the store, she was met by a white male later identified as the defendant, (Waylon Dwight Ganey) near the door wearing a white baseball cap with black trim, a white T-shirt and a white jacket. The adult male was also wearing white pants and was carrying a black backpack. Ms. Butterworth described the subject to be between 20 to 22 years of age with a visible tattoo on his neck. The defendant asked Ms. Butterworth for a ride to Mickey's Grocery Store located on Highway 189 in the Baker community. Ms. Butterworth agreed to provide the defendant with a ride and while traveling north on Highway 189, he requested to be dropped off at Golan Assembly of God Church located at 6612 Highway 189 Baker, Florida. The church is located approximately 1 mile north of Mickey's Grocery Store which is a little further than initially agreed upon.

While in transit to the church, Ms. Butterworth and the defendant engaged in conversation about people they knew in the community. Ms. Butterworth thought the subject looked familiar to her and inquired if he knew a lady named Barbara Sue? The defendant replied "Yes I know her and I know Nikki, her daughter." Ms. Butterworth asked the defendant, "Where does Nikki live?" The defendant replied, in the projects across from McDonald's in Crestview. After a few minutes of conversation, Ms. Butterworth and the defendant arrived at Golan Assembly of God Church. Upon reaching the church, the defendant reached for his backpack/bag in the back seat area of the vehicle and retrieved a black handgun from the backpack and pointed it at Ms. Butterworth. The defendant then stated "I'm sorry, but I'm gonna have to ask you to get out of the car." Ms. Butterworth in fear of being shot got out of the vehicle and the defendant crossed over to the driver's seat and sped away.

While responding to the scene, I observed what appeared to be the victim's vehicle southbound on Highway 4 at the intersection of Hwy 4 and Hwy 90 in Milligan, Florida. Due to traffic volume, I was unable to determine if the vehicle went East or West on Highway 90. This information was relayed to responding units as well as the Crestview Police Department. A Crestview Police Officer spotted the stolen vehicle southbound on PJ Adams Parkway and a vehicle pursuit was initiated. The defendant led law enforcement on a high-speed pursuit with speeds in excess of 100 mph to Highway 85, South on Highway 85 to Hwy 123 cutoff, South on General Bond to Lewis Turner Boulevard, South on Lewis Turner Boulevard to where the vehicle crashed into the Fantasy Lounge located at 1429 Lewis Turner Blvd.

When the vehicle crashed, the defendant fled the crash site on foot. A perimeter was established and Deputy Sheriff Tim Patterson along with K-9 Dax began a track of the defendant. During the K-9 track, several articles of clothing were located which included three men's shirts. A white tank top style shirt was located inside of a men's white polo style shirt. A short distance away was another white button up shirt. The articles of clothing appeared as though the clothes were removed by someone as they were running. The K-9 track led law enforcement behind a storage yard of an auto shop and up to a fence. Near the fence, a pair of men's blue jeans and a pair of men's white tennis shoes were located. Located inside the left rear pocket of the jeans was a wallet. Inside the wallet was a Florida Identification Card which depicted the name "Clayton Wendell Duffy." The K-9 track continued to behind the White Wilson Dermatology building. Located behind this building, was a pair of men's black ankle socks. A further canvass of the area resulted negative for the fleeing suspect and the search was terminated.

On this same date, February 26, 2014 at approximately 2135 hrs, Sgt. Mike Rader and I made contact with Waylon Ganey's sister, Nikki Ganey at 103 Lloyd St. Crestview, Florida. Both Waylon Ganey and Nikki Ganey are familiar to me from previous investigations and Nikki Ganey has always cooperated with law enforcement in the past. Nikki Ganey was shown the surveillance video from the Dollar General store which is where this incident initially began. The video depicts Waylon Ganey inside the store just prior to when he made contact with Ms. Butterworth. Through a sworn statement from Nikki Ganey, she positively identified her brother, Waylon Ganey as the person responsible and he was still wearing the same clothing as he was wearing earlier this same date at her apartment. Also located at 103 Lloyd St., was Nikki's boyfriend, Clayton Duffy who provided a recorted statement concerning Waylon possessing a black BB pistol with realistic design. Clayton Duffy also confirmed that his identification card had been stolen from his wallet within the past 24 hours. Per Clayton Duffy, he and Nikki Ganey told Waylon Ganey to vacate their apartment earlier this same date. Clayton Duffy also confirmed that Waylon Gazey left at approximately 0930 hrs, this same date carrying a black backpack.

Later this same date, February 26, 2014 at approximately 2215 hrs, the defendant, Waylon Dwight Ganey entered Fort Walton Beach Medical Center wearing nothing but shorts and was freezing from exposure. Perimeter units were still in close proximity and Ganey was immediately detained. Once detained, Waylon Ganey made several spontaneous

statements concerning the high-speed chase he was involved with and how he nearly froze from hiding on top of a building located in the area.

A cursory search of the victim's vehicle revealed a black backpack and a black BB pistol located inside. Also noted inside the vehicle was a ball cap that matches the same ball cap worn by Waylon Ganey while he was inside the Dollar General store located in Baker, Fl.

Based on the aforesaid facts, I have reason to believe that Waylon Dwight Ganey did in fact commit the offenses of Vehicle Theft and Robbery/Carjacking with a Firearm to wit: maliciously and intentionally using a black in color pistol with realistic features and or design as a weapon to rob victim, Bobby Butterworth of her 2010 Kia Soul. These offenses violate Florida State Statute 812.014.2c6 and 812.133.2a. Both offenses did occur in Baker, Florida, Okaloosa County.
