## **TWO NICEVILLE RESIDENTS CHARGED WITH INTENT TO DISTRIBUTE HEROIN**

A narcotics search warrant executed February 26<sup>th</sup> at a home in Bluewater Bay has led to the arrest of two people and the discovery of various illegal narcotics, including heroin.

The OCSO Street Crimes Unit, Drug Task Force, K-9 Unit, and members of the Criminal Investigations Section took part in the search at 515 Nassau Drive.

28-year old Danielle Beauchamp and 28-year old Evin Pace are charged with possession with intent to distribute heroin and possession of drug paraphernalia, including scales and needles.

Beauchamp was also arrested on an outstanding felony warrant for introducing contraband into the Okaloosa County Jail.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

In September 2012, I received information about the sale and use of narcotics, specifically heroin, occurring at 515 Nassau Drive, Bluewater Bay, Niceville, Florida. The suspects were identified as Danielle Beauchamp and Evin Pace.

During the course of the investigation, I was able to identify Beauchamp and Pace as residents at 515 Nassau Drive.

On Feb 19, 2014, a search warrant was signed by Judge Grinsted. On February 26, 2014, this search warrant was executed at 515 Nassau Drive, Bluewater Bay, Florida

During execution, Danielle Beauchamp and Pace were detained inside the residence.

During a search of the residence, on the kitchen table in plain sight, several small jewelers bags with residue, several unused small jewelers bags, several digital scales, weights to verify the digital scales were accurate, spoons with unknown melted substance, several used hypodermic needles, owe sheets, and price list were located.

Based on my training and experience, I know that the amount of jeweler's bags, digital scales, owe sheets, and price light are evidence of narcotic sales.

In a back bedroom, where most of Beauchamp's belongings were located, was a small prescription bottle with Beauchamp's name on it. Inside this bottle was a small jeweler's bag with a light brown substance, which tested positive for heroin.

During post Miranda interview, Beauchamp evoked her right to counsel. Pace would only state he was a narcotic user and did not sell narcotics.

During Post Miranda interview, two separate witnesses, who were inside the residence during execution of the search warrant, stated Beauchamp and Pace both sell narcotics, specifically heroin. One witness specifically stated he/she has bought heroin from Pace in the past. The other witness stated he/she has purchased several different narcotics from Beauchamp on a regular basis.

My investigation, which is based on the collection of physical evidence, interviews of the suspects, and witnesses, revealed Danielle Beauchamp did violate F.S.S. 893.13(1a1) - Possession of a controlled substance with intent to distribute and F.S.S. 893.147(1) - Possession of drug paraphernalia. This incident occurred in Okaloosa County, Florida.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On Aug 12, 2013 I arrested Franklin Page for an active warrant and driving while license suspended with knowledge. At the time of arrested, Page was driving Danielle Beauchamp's vehicle and Beauchamp came to the traffic stop location and picked up the vehicle.

At this time I began to listen to jail phone calls Page made to Beauchamp at 850-218-4846 to further a case. It should be noted, phone number 850-218-4846 was listed for Beauchamp in the Okaloosa County Sheriff's Office Master Name Index on September 7, 2011.

During phone calls made on Aug 14, 2013 and Aug 15, 2013, it was discovered Page received a card from Beauchamp at the Okaloosa County Jail. Furthermore, Beauchamp placed a suboxone strip under the stamp of the card. During the phone calls, Beauchamp states she placed a "fake address" and signed the card "your hippie chick", to keep law enforcement from linking her to the card.

While on the phone with Page, Beauchamp tells him she placed another card, with another suboxone strip under the stamp, into the mail box and he should get it within the next couple of days.

On Aug 16, 2013 I made contact with Corrections Officer Sam Fields at the Okaloosa County Jail and advised him of the information I received over jail phone calls.

On Aug 20, 2013 this card was intercepted by Okaloosa County Jail employees. The suboxone strip was located and the

Okaloosa County Sheriff's Office was contacted. Deputy Matthew Christmas responded to the Okaloosa County Jail and collected the envelope and its contents. Later that day, Deputy Christmas released these items to me.

During examination of the envelope, it was signed "Your Hippie Chick".

On Oct 23, 2013 FDLE lab results confirmed the orange strip under the stamp was suboxone. Suboxone is a Schedule III controlled substance per Florida State Statutes.

On January 30, 2014 Caitlyn Worthen called Beauchamp at phone number 850-218-4846 from the Okaloosa County Jail. During this conversation, Beauchamp stated "you used to be able to send Subs under stamps and stuff, but now they go through all that shit, if not I would send you something".

Based on my training and experience, I know "Subs" to be street slang for suboxone.

On February 5, 2014 Worthen called Beauchamp again from the Okaloosa County Jail. During this conversation, Beauchamp states "when Frank went in for a week I mailed him one, behind a stamp, and he got the first one. Then I did it a second time and the second time they confiscated it. Apparently now when you get mail they rip the stamp off"

It should be noted I have personally talked to Beauchamp on several occasions and I was able to identify her voice on the phone calls. Furthermore, Page calls Beauchamp by her nickname "Dani" and they discuss specifics about the night I arrested Page.

My investigation, which is based on collection of physical evidence, revealed Danielle Beauchamp did violate F.S.S. 951.22-Smuggling Contraband into a Detention Facility. This incident occurred in Okaloosa County, Florida.
