SEXUAL BATTERY SUSPECT IN CUSTODY



A man wanted in connection with breaking into a Tanager Road home and raping a female resident February 5th is now in custody.

28-year old Marcus Thomas Wooley of 814 Tanager Road, Apartment B, was located around 9:15 last night at a home on Lark Street by the Okaloosa County Sheriff's

Office in conjunction with its Street Crimes Unit, Drug Task Force, and the U.S. Marshals Service Fugitive Task Force.

The victim says Wooley, who she knows, broke into her home through a window while she was sleeping. Although he was wearing a beanie cap, sunglasses, and blue latex gloves, the victim says she recognized his smell (either his cologne, deodorant, or shampoo) as well as his voice when he talked to her. The victim says he forced her to have sex and when she asked him why he was doing that to her, he replied "I don't care if you're eight or eighty – cripple, blind or crazy".

After the suspect left out the front door, the victim was evaluated at Fort Walton Beach Medical Center where a nurse practitioner said she had bruising and injuries consistent with nonconsensual sexual intercourse.

Wooley is charged with sexual battery and burglary with assault or battery.

On 02/05/14, members of the Okaloosa County Sheriff's Office responded to Tanager Road, ////Fort Walton Beach, Florida, in reference to a Home Invasion where the victim reported (Marcus Wooley) had sexually battered her.

asking her to pick up some clothing of clothing. While at Wooley's residence, Wooley asked ////if anyone was going to be at her residence with her. She did not think anything of it at the time and told him that she did not feel good and was going to sleep. ///// returned to her residence and cooked herself a hamburger. 2//// fell asleep again around 2330-0000 hours. to someone touching her shoulder. She looked to the side of her bed and saw Wooley standing next to her bed. When asked how she knew it was Wooley, she told me she could tell by his smell. She explained the smell to be his scent, unknown if it was his cologne, deodorant, or shampoo. ////also stated that after Wooley began to talk she recognized his voice as //// She further explained she did not see his eves and face because he was wearing a beanie cap, sunglasses, and blue latex gloves. She asked him how he got in, and he said he has been in her residence several times watching her sleep. Wooley told that this was his last chance, as he was moving out of his residence this week, for her to have sex with him. She told him that she had not had sex in 14-15 years. Wooley replied that she was going to have sex with him. ///// told Wooley that she did not want to have sex with him. She told me she would not have sexual intercourse with Wooley as he was in his 20's and she had not had sexual intercourse in several years. "asking for it" as she had been wearing low cut shirts showing off her large breasts.

stated she was wearing a pajama shirt, a bra, and her underwear to sleep in. She said when Wooley took her clothing off of her, she said he "yanked it off". At that time, Wooley had vagina and anal intercourse with said Wooley was acting "like a monster". explained Wooley held her down onto the bed by her shoulders. She said at one point her right hand was under her back as he continued to pin her down on the bed by her shoulders. Wooley had sex with her both ways, vaginal and anally. stated the incident did not last a long period of time but it felt like a "life time" to her. membered at one point that Wooley was holding a stick near his privates (penis) and said, "If this isn't big enough, I got a stick". Wooley proceeded to have vaginal and anal sexual intercourse with her as he was on top of her. Wooley told [777] that he liked older and younger women "8 to 80". asked Wooley why he was doing this to her, and told him that she was [7] rears old woman. Wooley replied, "I don't care if you're 8 to 80; cripple, blind, or crazy."

When asked if Wooley ejaculated, she stated he ejaculated "in her", on her, on the bed sheets, and on the comforter. After Wooley ejaculated /////stated he exited the residence through the front door. /////remembered hearing the dead bolt on the door unlock which made her realize that he did not come through the front door.

Following the sexual assault collection kit being collected at the Fort Walton Beach Medical Center, ARNP Buckallew stated during the exam had bruising to her vaginal and anal area consistent with non-consensual sexual intercourse. She also stated with the fort was a consistent with non-consensual sexual intercourse.

Attempts were made to locate Wooley for an interview, but none were successful.

Based upon the above facts, it is believed that Marcus Wooley committed the offenses of Sexual Battery per F.S.S. 794.011 (4)(b) and Burglary with Assault or Battery per F.S.S. 810.02 (2)(a). This offense occurred within Fort Walton Beach, Florida, within Okaloosa County where I am a sworn Law Enforcement Officer.
