## MARY ESTHER TEEN CHARGED IN BASEBALL BAT ATTACK



The Okaloosa County Sheriff's Office has charged a Mary Esther teenager with aggravated battery after he struck a man in the head with a baseball bat during an altercation. 18-year old Darrell Wayne Hopkins of 499 Cypress Street is accused of getting into an argument with Northern Pine Road homeowner Joseph Birr on January 11<sup>th</sup>. Investigators say Hopkins drove his car to West Ponderosa Road, then he, 32-year old

Derek Griese, and another teen went back to 115 Northern Pine to fight with Birr. Birr meantime had gone into his home and gotten two baseball bats. He was hit from behind and fell to the ground, dropping the bats. Hopkins then picked up one of the bats and used it to strike 36-year old Luke McEwan of 114 Northern Pine Road, who had come to Birr's aid. McEwan suffered a head injury and spent four days in the hospital.

Hopkins was arrested January 21<sup>st</sup>.

#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 1/11/2014, at approximately 2200 hours Anthony Fannin, Gabriella Reichlin-Powley, Aaron Olmstead, William Martin and Kaitlin Kestner were riding in Katelin Kestner's white 2005 Ford Escape bearing Florida tag BVWV96, which was traveling east on Northern Pine Road en route to Aaron Olmstead's residence at 1524 WestPonderosa Road, Fort Walton Beach, Okaloosa County Florida. Joseph Birr stopped the vehicle in the roadway in front of his residence, 115 Northern Pines Blvd, and a verbal argument ensued. Kestner drove around Birr and drove the vehicle to 1508 West Ponderosa Road. Darrell Hopkins and got out of the vehicle and proceed back to 115 Northern Pine and Hopkins approached the residence, Birr exited his residence with two baseball Road to fight with Birr. As bats. As Birr was confronting and Hopkins, Derek Griese came onto Birr's property, approached Birr from behind and struck him in the head, knocking Birr to the ground. As a result, Birr dropped the baseball bats he was and Hopkins proceeded onto Birr property and picked up and armed themselves with the bats. Luke carrying. McEwen, who was in a guest at Birr's residence, came out to assist Birr and confronted 1 and Hopkins. As McEwen and Hopkins, Hopkins hit McEwen in the head with the bat he had armed himself with. confronted

Luke McEwen suffered fractures to his skull and a leg injury form the confrontation. McEwen was taken to Fort Walton Beach Medical Center, 1000 Mar Walt Drive, Fort Walton Beach Florida. McEwen spent two day in Intensive Care (ICU) due to bleeding and swelling from his head injury. McEwen was then transferred to a regular room for observation, McEwen was released from the hospital on 1/15/2014.

In a post Miranda interview Hopkins admitted he proceeded to 115 Northern Pine Road with the intent to fight Birr and McEwen, and during the confrontation he hit McEwen in the head with the baseball bat Birr had dropped. This was also confirmed by Anthony Fannin's statements.

Based on the aforementioned information I have reason to believe and do believe Darrell Hopkins violated F.S.S. F.S.S. 784.045 aggravated battery. This incident occurred in Okaloosa County Florida where your Affiant is a sworn Law Enforcement Officer.
