FWB MAN CHARGED WITH AGGRAVATED BATTERY AND KIDNAPPING IN CONNECTION WITH DOMESTIC VIOLENCE INCIDENT



A Fort Walton Beach man faces multiple felony charges after Okaloosa County Sheriff's Office deputies investigated a domestic battery that took place June 15th.

50-year old Patrick James Conaty of 439 Waterway Lane is charged with domestic battery by strangulation, aggravated battery causing great bodily harm, kidnapping, and violation of pretrial

release conditions.

Deputies were called to Fort Walton Beach Medical Center June 15th where the victim, Tess Sweeney, was found to have lacerations to a leg and bruising around her throat.

Sweeney says she and Conaty got into an argument over a previous arrest for domestic battery in which she was the victim. Around one a.m., he pushed Sweeney into a full length mirror, causing the cuts to her leg. Sweeney says Conaty then grabbed her by the throat and chocked her until she lost consciousness. When she regained consciousness and tried to leave the home, she says Conaty grabbed her by the throat again and pinned her to the wall until she lost consciousness a second time. Sweeney was able to get away and travel to the hospital.

Deputies found Conaty hiding on the back patio of 445 Waterway Lane. He told them Sweeney walked into the mirror.

Based on the previous arrest, a no contact order had been issued April 23rd stating that Conaty was to have no contact with Sweeney. While Sweeney was in the hospital, deputies say she continued to get Facebook messages from Conaty. In addition, since the no contact order had been issued, Conaty and Sweeney had gotten married.

On 06/15/2014 at 0133 hours, I, D/S Mark Mitchell responded to the Fort Walton Beach Medical Center in reference to a domestic battery. Upon my arrival I made contact with the victim, Tess Sweeney.

I observed two lacerations on Sweeney's right knee, requiring thirteen stitches to repair the injury. Sweeney also had bruising around her throat area consistent with being strangled.

Per sworn written statement, Sweeney stated her and her husband, Patrick Conaty, got into a verbal altercation over the defendants recent arrest for domestic battery in which Sweeney was the victim. The defendant had been drinking all night causing his aggression level to escalate. Around 0100 hours, the defendant pushed Sweeney into a full length mirror causing the lacerations to her knee. The defendant then grabbed Sweeney by the throat and pinned her up against a wall in their bedroom, applying enough pressure to cause Sweeney to lose consciousness. When Sweeney regained consciousness and tried to leave the residence, the defendant again grabbed her by the throat, pinned her against the wall, causing her to lose consciousness. After regaining consciousness the second time, Sweeney was able to exit the residence and travel to the hospital.

Deputies responded to 439 Waterway Lane, Fort Walton Beach, FL, where the incident occurred. Deputies on scene observed a broken mirror and blood on the floor consistent with Sweeney's statement.

I located the defendants motorcycle several houses down from Sweeney's residence, indicating that he was still in the area. Deputies were able to locate the defendant hiding on the back patio behind 445 Waterway Lane. The defendant was taken into custody. Post Miranda, the defendant denied all of the allegations and stated Sweeney walked into the mirror causing her leg injury.

Based on an a previous arrest, a no contact order was issued on 04/23/2014 by the First Appearance Judge for the defendant to have no contact with Sweeney. While Sweeney was at the hospital, she was receiving continuous messages via Facebook from the defendant in my presence. Additionally, since the no contact order was ordered, the defendant and Sweeney got married.

Based on the above probable cause, I have reason to believe and do believe that the defendant committed the offenses of Domestic Aggravated Battery F.S.S 784.045(1)(a)1, Domestic False Imprisonment F.S.S 787.021(a), Domestic Battery by Strangulation F.S.S 784.041(2)(a) and Violation of Pre-trial Release Conditions F.S.S 741.29(6).
