WARRANT SERVICE LEADS TO METH LAB DISCOVERY



Deputies who went to a Crestview area home to serve a misdemeanor violation of probation warrant Monday found an active meth cook taking place.

27-year old Jonathan David Miller of 2420 Lake Silver Road is charged with trafficking in methamphetamine and possession of drug paraphernalia.

Deputies on scene to arrest Miller on a VOP battery charge saw drugrelated items in plain view, including a large metal spoon with a white substance, hypodermic needle caps, and lithium strips.

The Okaloosa County Multi-Agency Drug Task Force responded and located approximately eighty grams of suspected methamphetamine oil inside a bottle on the kitchen counter and other meth lab items.

Miller told deputies he both used and manufactured methamphetamine.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On March 3rd, 2014, Sergeant Micah Redmon, along with Deputy Richard McCoy and Deputy Cameron Kaltz, went to 2420 Lake Silver Road, Crestview, Florida, in order to serve an active arrest warrant on the defendant, Jonathan David Miller. This residence is within Okaloosa County, Florida.

During the execution of the arrest warrant, several items were observed in plain view, indicating to Sergeant Redmon that an active methamphetamine lab may be inside the residence. Based on his observations, Sergeant Redmon requested the assistance of the Okaloosa County Multi-Agency Drug Task Force.

In a post Miranda interview, Miller admitted to both using and manufacturing methamphetamine, although he would not elaborate on how, when, or where he would manufacture methamphetamine. He admitted to using methamphetamine within the past 27 hours.

Miller provided voluntary consent to search the residence in the form of a signed permission to search form. During the subsequent search, approximately 80 grams of suspected methamphetamine oil was located inside of a "SmartWater" bottle, located on top of the kitchen counter. This oil tested positive for the presence of methamphetamine using a presumptive field test kit. Also found inside of the residence were several items indicative to the use and/or manufacturing of methamphetamine, including coffee filters, aluminum foil, pseudoephedrine packets, used syringes and syringe caps, lighters, and spoons.

Donald Christopher Weekley Junior was also present during the execution of the arrest warrant. During a post Miranda interview, Weekley stated that Miller was manufacturing methamphetamine. Weekley stated that he was at the address in order to obtain methamphetamine from Miller for personal use.

Based on the above, your Affiant has probable cause to believe that the defendant, Jonathan David Miller, violated F.S.S. 893.135(1f1), Trafficking in Methamphetamine; and F.S.S. 893.147(1), Possession of Drug Paraphernalia.
