TEEN DRIVER FACING MULTIPLE CHARGES AFTER COLLIDING WITH PATROL CAR



A Fort Walton Beach teen faces charges ranging from leaving the scene of an accident and careless driving to DUI.

Deputy Steve Baldwin spotted a silver Hyundai around 4:30 last night that matched the description of a car that had collided earlier with several other vehicles in the Kmart parking lot in Fort Walton Beach. The driver had left the scene.

Deputy Baldwin pulled over the driver on Clifford Street but says the teen would not comply with his requests, instead putting his car in reverse and backing into the Deputy's patrol car. The driver, later identified as 18-year old Treyvon Cannon-Riggs of Fort Walton Beach, then ran over a satellite dish and a large green trash can and sped off towards Beal Parkway at a high rate of speed, escaping into heavy traffic.

Cannon-Riggs' car was later found abandoned inside Pinecrest Mobile Home Park off Racetrack Road. He was taken into custody after being located at a trailer on Beal Parkway.

The Okaloosa County Sheriff's Office has charged Cannon-Riggs with DUI, hit and run, careless driving, aggravated fleeing and eluding, resisting an officer, and driving on a suspended license, along with multiple other traffic violations.

On 05/06/14, at approximately 1635 hours, I was in my marked patrol vehicle traveling south on Beal Parkway near Clifford Street. A BOLO for a silver in color Hyundai Sonata displaying Idaho tag CBJ048 had been issued earlier by Dispatch (OCSO14CAD080104). The BOLO had been issued reference to intoxicated driver who had hit several vehicles in the Kmart parking lot.

As I was passing the QV Gas Station located at 757 North Beal Parkway, I observed a vehicle matching the BOLO description. The silver in color Hyundai appeared to be stalled in the north bound outside lane with traffic backing up behind it. As I passed the vehicle, I observed the Hyundai had an Idaho license plate. At that point, I turned my patrol vehicle around and observed the silver in color Hyundai accelerate from a dead stop and make a right turn onto Clifford

I advised OCSO Communications that I believed I was behind the BOLO vehicle. I activated my emergency equipment to initiate a traffic stop. The driver pulled the Hyundai into the driveway/parking lot of 161 Clifford Street. I advised OCSO Communications that I was conducting a traffic stop and confirmed the vehicle was in fact the vehicle issued in the BOLO. My marked patrol car was parked directly behind the Hyundai with emergency response lights activated.

I exited my marked patrol vehicle and approached the Hyundai. I observed one occupant who was seated in the driver's seat behind the steering wheel. The occupant was not wearing his seat belt. The occupant was described as a black male with dread locks later identified as Treyvon Darelle Cannon-Riggs. (I later positively identified Cannon-Riggs via photograph in the OCSO Master Name Index, this photo was shown to me by Deputy Kourtney Spruill at the scene.)

I approached the driver side window and identified myself as a law enforcement officer. Mr. Cannon-Riggs turned towards me, made eye contact with me and then turned away to use his cell phone. Mr. Cannon-Riggs appeared to be under the influence of some unknown substance. Cannons-Riggs was slow with his body movements and his eyes appeared glassy and bloodshot.

I made two verbal requests for Cannon-Riggs to roll down his driver side window and put both his hands on the steering wheel. Cannon-Riggs rolled his window half way down and put his left hand on the steering wheel. I then made two more verbal requests for Cannon-Riggs to put the cell phone down and place his right hand on the steering wheel.

Mr. Cannon-Riggs stated in a slurred and mumbled voice that he was trying to call his mother. I made one more verbal request to Cannon-Riggs to put his cell phone down. He refused my request and I attempted to open the door and remove Cannon-Riggs from his vehicle. The vehicle's left driver's door was locked.

It was at this point Mr. Cannon-Wells said "Nope", rolled up his driver's window and put his vehicle in reverse, backing approximately 3 feet striking the front end of my vehicle. This caused approximately \$500.00 in damages to my patrol vehicle's paint.

Mr. Cannon-Riggs than placed his vehicle into drive and drove forward. For officer safety reasons I removed my hand from the door handle and instructed Mr. Cannon-Riggs to stop, several times! The Hyundai made a swerving motion to the left and ran over a satellite dish, a large green trash can, approximate cost of the damage to be determined upon contact with the property owner.

The Hyundai then proceeded to make another left turn and drove between two parked vehicles finally exiting onto Clifford Street. The Hyundai drove west on Clifford Street towards Beal Parkway at high rate of speed. I advised OCSO Communications that the Hyundai had backed into my marked patrol car and was fleeing the scene with property damage.

I ran to my patrol car and activated my siren to give pursuit, however I lost the vehicle in heavy afternoon traffic at the intersection of Clifford Street and Beal Parkway.

Mr. Cannon-Riggs was later apprehended and taken into custody at 130 Fetting Avenue, FWB, located just off North Beal Parkway. Cannon-Riggs had abandoned the Hyundai behind 130 Fetting Avenue (inside of Pinecrest Mobile Home Park). Cannon-Riggs had met with his mother and a black male known only as Chris. Cannon-Riggs then entered his grandmother's trailer located at 130 Beal Parkway where he was subsequently apprehended by law enforcement. This information was obtained by Deputy K. Spruill.

I later responded to 130 Fetting and positively identified Treyvon Cannon-Riggs in the back seat of a marked patrol vehicle.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 05/06/2014, Treyvon Cannon-Riggs was identified as the suspect in a hit and run involving an Okaloosa County Sheriff's Office marked patrol vehicle at 161 Clifford Street, Fort Walton Beach, Florida.

On this date, a BOLO was given out on Cannon-Riggs' vehicle when he was involved in a traffic crash at K-Mart located in Fort Walton Beach. D/S Stephen Baldwin, who was operating a marked OCSO patrol vehicle, observed Cannon-Riggs' vehicle stopped on Beal Parkway. D/S Baldwin attempted to get behind the vehicle and the vehicle sped away at a high rate of speed then proceeded down Clifford Street in a unsafe manner. D/S Baldwin initiated his emergency traffic lights and attempted a traffic stop on Cannon-Riggs' vehicle. The vehicle came to a complete stop at the above address and D/S Baldwin attempted to establish contact with the Cannon-Riggs. Cannon-Riggs was on the telephone and was ignoring D/S Baldwin's commands to get off the telephone. During the contact, D/S Baldwin believed Cannon-Riggs was under the influence of an unknown substance. Cannon-Riggs' speech was slurred, he movements were slow, and his eyes were glassy. Cannon-Riggs refused to give D/S Baldwin his drivers license, registration, and proof of insurance.

After multiple commands were issued by D/S Baldwin, D/S Baldwin attempted to open the driver's door to get Cannon-Riggs out of the vehicle. Cannon-Riggs refused to comply with D/S Baldwin and put his vehicle in reverse then proceeded by backing his vehicle into D/S Baldwin's patrol vehicle. Cannon-Riggs then put the vehicle in drive and drove away from D/S Baldwin.

The tag of the vehicle driven by Cannon-Riggs returned to his residential address and the information was given over the radio. An Investigator with the Okaloosa County Sheriff's Office was familiar with the address and notified Sgt. Jerard that Cannon-Riggs resides at that residence. Cannon-Riggs' M.N.I. jacket was located and D/S Baldwin identified Cannon-Riggs as the driver by his mug shot in M.N.I.

Cannon-Riggs was located in Pinecrest Mobile Home Park by other Deputies and Cannon-Riggs was taken into custody without further incident. Cannon-Riggs was transported to the Okaloosa County Courthouse Annex Extension. FHP Trooper Hurst conducted a DUI investigation in reference to another crash in which Cannon-Riggs was identified as the suspect. Cannon-Riggs refused to conduct Standard Field Sobriety Task with Trooper Hurst and blew a .000 BAC. Cannon-Riggs also refused to provide a urine sample. The results from Trooper Hurst's DUI investigation were given to this Deputy. A check of Cannon-Riggs' drivers license revealed the license was suspended on 04/22/2014.
