## OCSO ANNOUNCES ARREST OF DEPUTY SHERIFF

Sheriff Larry Ashley today announced that the Okaloosa County Sheriff's Office has arrested an OCSO deputy on a felony charge of unlawful sexual activity with a minor.

31-year old Deputy Christopher Ball, who has been with the agency less than one year, is also suspended without pay pending termination.

"I demand, and our profession demands, that our deputies conduct themselves with the highest standards of integrity and moral conduct. Behavior that undermines that standard will absolutely not be tolerated. Within 24 hours our investigators had taken action to quickly and thoroughly determine the facts in this case and to carry out the appropriate steps to protect the public. We are now conducting a separate internal investigation and that information will be made public as well at the appropriate time," said Sheriff Larry Ashley.

OCSO Investigators say Ball became involved in a sexual relationship with a 17-year old girl in December 2013. During a forensic interview with the victim yesterday, she outlined that she and the defendant had sexual intercourse six times at three different locations. Investigators say Ball made admissions to being in an inappropriate relationship but denied sexual contact. He consented to a search of his cell phone and admitted some scantily clad and nude photos located on the phone were of the victim.

Ball had been hired May 20<sup>th</sup>, 2013.

Contact was made with a witness who provided a sworn statement stating she found out about the alleged relationship between the Defendant and the victim around March 2014 by accident when she discovered the victim was sexually active and taking birth control. The witness stated on May 3, 2014, she allowed the victim to move												
into her residence and made it known to the victim that she was to have no further communication with the Defendant. The witness also advised she went through the victim's text messages from April 7, 2014, through May 3, 2014. She advised there were several suggestive messages between the two, but nothing that outright said

On May 8, 2014 a search warrant was signed by the Honorable Judge Stone and executed on the victim's cellular telephone. A photograph was located of a female's buttocks wearing black underwear.												
On May 9, 2014 the defendant was interviewed, post Miranda advisement, and gave several admissions to being in an inappropriate relationship, but denied sexual												
contact. He stated she was infatuated by him and he was flattered. He stated that if she was over eighteen years of age he would have had sex with her, and that he												
continued the relationship with her because "She would turn eighteen someday." After several denials he admitted that he was alone with the victim at all three locations where the sexual intercourse occurred.												
During the interview he provided consent to search his cellular phone. On his phone was located several photos of a female in bra and panties as well as exposed												
breasts and pubic area in which the face was not visible. One photo of a female's buttocks wearing black underwear was located his phone, This is the same photo												
located on the victim's phone	e. When confronted with	the photos he a	dmitted that they	were pho	tos of the victim	that she	e had ta	ken an	d sent to	him.		
I have reason to believe and do believe the Defendant, Christopher David Ball is in violation of F.S.S. 794. 05, Unlawful sexual activity with certain minors. This offense did occur in Okaloosa County, where I am a sworn Investigator with the office of the sheriff.										se
