VIGILANT NEIGHBOR HELPS OCSO NAB TRIO OF BURGLARS

A Destin man wasn't going to just stand by and watch three people steal his neighbor's \$15,000 boat propeller.

When he spotted the trio go onto property at 107 Durango Road Tuesday and load the prop into a car with an Oklahoma tag, he followed them while calling his neighbor to ensure no one was supposed to be taking it away.

Once he verified it was being stolen, he called the Okaloosa County Sheriff's Office and followed the suspects' car until a Deputy arrived to make a traffic stop.

The deputy found the prop in the rear compartment and learned they were planning to take it to sell as scrap metal for cash.

36-year old Scott Tubb, (address unknown), 17-year old Colton Brewer of Santa Rosa Beach, and 36-year old Nicholas Harris of Destin are all charged with burglary and grand theft.

"This is a perfect example of a citizen looking out for his neighbors and his community, and being willing to take the time to be extra eyes and ears for law enforcement," said Sheriff Larry Ashley. "I want to applaud him for doing the right thing by not trying to engage the suspects but instead immediately relaying the information so a trained officer was able to then make the traffic stop and the arrests."

These subjects got inside of the Honda Element and left the scene. Duplantis got into his vehicle and followed the Green Honda Element.

While following the vehicle, Duplantis contacted his neighbor, Colin Kirkwood, and verified that no one was supposed to take the boat propeller. Duplantis then contacted the Sheriff's Office. Duplantis followed this vehicle from the area of the theft until it was stopped by the Okaloosa County Sheriff's Office in front of 509 Harbor Boulevard, Destin, Florida.

Deputy Jose Pereira stopped this vehicle and found three subjects inside, identified as Colton Brewer (driver), Nicholas Harris (passenger), and Scott Tubb (passenger). Deputy Pereira also observed a boat propeller sitting in the rear vehicle compartment. These were identified as the same subjects that Duplantis observed loading the boat propeller from 107 Durango Road.

In a verbal interview post Miranda, Brewer confessed to going onto the property and taking the propeller. He stated that he was in the area with Harris and Tubb, looking for scrap metal. They decided together to take the propeller from the property. He stated that he did not get permission to enter the property, nor did he get permission to take the boat propeller. Brewer stated admitted that Harris and Tubb assisted him with carrying the propeller, due to its weight.

In a verbal interview post Miranda, both Harris and Tubb denied involvement in the theft. They claimed that they were picked up by Brewer while they were walking on Highway 98 about a minute and a half before being stopped by law enforcement.

Colin Kirkwood, the owner of the boat propeller, stated in a verbal interview and sworn written affidavit that he was the owner of the boat propeller. This propeller was left leaning up against a brick partition in front of his house (107 Durango Road, Destin, Florida.) This location was well off the side of the roadway in a nonpublic area. He stated that he did not give anyone permission to take the propeller. He estimated the value of the propeller to be between \$10,000 and \$15,000.

Based on the above information, your Affiant has probable cause to believe and does believe that Colton Brewer committed a violation of Florida State Statutes 812.014(2c3): Grand Theft (More than \$10,000 but less than \$20,000); and \$10.02(3b): Burglary of an Unoccupied Dwelling. This violation occurred in Okaloosa County, Florida, where your Affiant is a sworn law enforcement officer.
