BURGLAR CAUGHT TRYING TO STEAL FROM DEPUTY'S PERSONAL VEHICLE



A Crestview man quickly found himself wearing handcuffs after he picked the wrong truck to burglarize.

A Walton County Deputy who lives in Crestview caught a man in the act of trying to steal a Yeti cooler valued at \$400 out of the back of his personal vehicle around five a.m. Friday morning. Deputy Jonathan Smith says while preparing for work, he spotted a man near the back of his truck. The man was using a pair of metal shears to try to cut the cables that secured the cooler inside the truck bed. Deputy Smith, who was in uniform, ordered 37-year old James Chestnut of 6122 Kimberly Lane onto the ground where he put him in handcuffs and detained him until deputies from the Okaloosa County Sheriff's Office arrived. Chestnut told Deputy Smith he just "wanted a beer". He's now charged with burglary, possession of burglary tools, and attempted grand theft.
