CRESTVIEW MAN THREATENS NEIGHBORS WITH KNIFE



A Crestview man faces multiple charges after neighbors say he smashed a window, threatened to kill them, and tried to stab his way through a door. The Okaloosa County Sheriff's Office has charged 38-year old Landon Lamar Blair of 3650 Grady Johnson Road with assault with intent to commit a felony, burglary, and criminal mischief. Deputies responded October 14th to a call of a disturbance in progress at 3652 Grady Johnson Road. Blair was spotted entering his home next door.

His neighbor says she woke around 6:20 a.m. to the sound of breaking glass and found her living room window broken. She says Blair was walking away and told her he was going to come back and kill her and her children for bothering him. He then returned and threatened them again through the broken window, pulled out a knife from his boot, and stabbed around the window frame before heading to the front door and trying to pull it open. The victim says she had locked the door and pulled on the handle to keep it shut. She says Blair continued to yell threats and began to stab through the door with his knife. When she told him she had called law enforcement, he left and went to his home.

Deputies say Blair told them he remembers coming from his neighbor and entering his gate but refused to answer any other questions. They found a deep cut and several smaller lacerations on Blair's arm. They also found an empty knife sheath attached to his belt line on the right side of his waist. When they recovered the knife, its blade was consistent with the holes in the door.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/14/14 I responded to 3652 Grady Johnson Road, Crestview Florida in reference to a Disturbance in progress.

Upon arrival I observed Landon Blair entering his residence on 3650 Grady Johnson Road next door to the callers residence. I made contact with Michelle Sheats who stated that at 0620 hours she awoke to the sound of breaking glass. Upon investigating the situation, Sheats observed her living room window broken and Landon Blair walking away form her residence. Sheats asked him what he was doing and he stated he was going to come back and kill her and her kids for bothering him all night. Within 5 minutes, Blair returned and shouted through the broken window that he was going to kill them all. Blair proceeded to pull a knife from his boot and then broke the window above where it was already broken and stabbed around the window frame. Blair then went to the front door and attempted to pull it open. Sheats had locked the door and was pulling on the handle to keep it shut. Blair continued to stated he was going to kill Sheats and her kids and began to stab through the door with his knife. Sheats then called law enforcement and upon telling Blair that law enforcement was on the way he left her residence and went to his.

Post Miranda Warring, Blair stated he remembers coming from his neighbor and entering the gate to his residence. Blair refused to answer any further questions. I observed one deep and several smaller lacerations on Blair's arm and they were consistent with scars that would be sustained from breaking a glass window. The large laceration was on the interior of his right arm near the front of his elbow. That laceration was jagged in nature, and required multiple sutures to close the wound. Additionally, he had an empty knife sheath attached to his belt line on the right side of his waist. The knife was recovered and was consistent with the holes in the door and wall.

Based on the above mentioned facts I do believe Landon Lamar Blair did violate Florida State Statute 784.021.1b Assault With Intent To Commit AFelony, 806.13.1b2 Damage to Property- Criminal Mischief \$200 but less the \$1000, and 810.02.2b Burglary to Dwelling, Structure or Conveyance Armed.
