TWO TEENS ENGAGE IN DESTIN CRIME SPREE

The Okaloosa County Sheriff's Office has charged two teens in connection with a string of crimes Saturday evening in Destin.

The first call involved a report around 6:30 p.m. of two young white males entering the Liquored Up store at 4618 Opa Locka Lane and taking three bottles of Taada wine. A witness recognized the pair and identified them as 18-year old Robert Arena and 17-year old Garret Hamilton. While investigating this call, the OCSO received a report at 6:43 p.m. of two males entering cars at a home on Amhurst Circle. The pair matched the description of the two individuals believed to have just stolen items from Liquored Up. Deputies arrived and began foot patrols of Calusa Bay and the surrounding area. During the search, a call came in of a car burglary in progress at Papaya Park. The owner says she went into her garage and saw a male approximately 15 to 20 years old wearing a white shirt leaving the garage and heading towards Tranquility Lane.

As deputies continued to search, Sgt. Michael Brake saw a black Buick Rendezvous approach him and go onto Regatta Bay Boulevard. Sgt. Brake also noticed a garage door open on Sunsail Circle and made contact with the owner to suggest he close his garage, due to a spate of recent burglaries. The homeowner discovered his car, a dark Buick Rendezvous, was missing. In the meantime, a loss prevention officer at the Destin Wal-mart reported two

white males entering the store and trying to exit without paying for three 24-packs of Bud Light and a bag of Doritos.

When confronted, one suspect dropped his beer and ran away. The second got into a dark colored Buick Rendezvous and fled onto Henderson Beach Road. A deputy attempted a traffic stop but the car sped away. After a brief chase, the pursuit was called off as the car drove east on Scenic 98 towards Walton County.

In the surveillance video from Wal-Mart, the subject in the white shirt had a noticeable black smudge on his left side pocket. A short time later, two deputies stopping to eat at Wendy's saw the individual in that shirt at the Waffle House. They made contact with him and confirmed his identity as Robert Arena. Arena stated he had been with Hamilton prior to being at the Waffle House. Arena denied committing any crimes.

Arena was charged with two counts of burglary and two counts of retail theft.

Hamilton of 315 Sailfish Circle in Destin was located today and charged with grand theft of a motor vehicle, three counts of burglary, resisting arrest, and two counts of retail theft.

On 10/25/14, I responded to Liqueured-up located at 4618 Opa Locka Lane, Destin, Florida, in reference to theft. Upon arrival I made contact with the reporting person Anthony Melvin, and witness Coby Smith.

Melvin advised a male later identified as Garrett Hamilton, entered the liquor store. A second male later identified as Robert Arena, walks in and stands next to Hamilton where they speak briefly to one another.

Hamilton then removes three bottles of "Taaka" wine from the shelf and heads for the door with Arena, where they both are seen running from the scene with the bottles.

A witness, Coby Smith observed Hamilton and Arena running from the store after learning of the theft from Melvin, then chased after them, but soon lost visual. The theft was caught on in-store video as well as Smith identifying both males.

Based on the information and witness accounts. I have reason to believe and do believe, the defendant Robert Arena, violated Florida State Statute, 812.0143a THEFT, and actions of the defendant are contrary to the peace and dignity to the State of Florida. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.



Mitchell advised in as sworn affidavit of complaint that two males later identified as Robert Arena and Garrett Hamilton entered the attached garage while Mitchell and his friends were inside.

Hamilton and Arena were then observed opening the driver's side door of both Mitchell's vehicles and rummaging through the glove box scattering the items throughout the vehicles interior. Hamilton used his shirt to open the vehicle door and Arena used his jacket sleeve to close it, in an attempt to avoid leaving fingerprints.

Nothing was missing from the vehicle at this time. The vehicles entered was a black 2013, BMW bearing Florida tag #071QAS, the other vehicle was a Nissan 2013, GTR bearing Florida tag #NB7725. This offense was caught on Mitchell's personal security system. Both Hamilton and Arena were identified through this video, as well as prior footage from a recent offense occurring in this area.

Based on the information and video evidence, I have reason to believe and do believe the defendant Robert Arena, violated Florida State Statute 810.02.4b BURGLARY/CONVAYANCE and 810.03.3b BURGLARY and the actions of the defendant are contrary to the peace and dignity to the State of Florida. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/25/14 Robert Arena committed the offense of retail theft at Wal-mart, 15017 Emerald Coast Parkway, Destin, FL. Arena took one 24 pack of Bud Light with the intent to deprive the merchant of possession, use, benefit, or full retail value

At approximately 2018 hours on 10/25/14, LPO John Sullivan observed two white males in the store. One of the males was wearing a blue t-shirt and was carry two 24 packs of Bud Light and a bag of Doritos chips. The second male, later identified as the defendant Robert Arena, was wearing a white zip-up hooded sweatshirt and was carry a 24 pack of Bud Light. Both subjects walked passed all points of sale and towards the exit. They walked passed the first security

system and were in between the double door exits with the merchandise in hand. Sullivan approached them and identified himself. Arena placed his pack of Bud Light down on the ground and ran out of the store resisting Sullivan's efforts to detain them.

I viewed surveillance footage of the subjects. Arena was wearing a white zip-up hooded sweatshirt with a black stain on the left front pocket along with khaki shorts. In the video you can see he had brown hair and was a thin white male.

Arena was located at Waffle House, 1067 U S Highway 98, at approximately 2130 hours. He was wearing a white zip-up hooded sweatshirt with the same black stain on the left front pocket and khaki shorts. He was detained and Sullivan completed a show-up. Sullivan positively identified Arena as one of the males who were in Wal-mart stealing the Bud Light cases.

Post Miranda, Arena admitted to being in Wal-Mart with his friend Garrett Hamilton. He was shown photographs of the two subjects described by Sullivan and admitted to being the subject in the white zip-up hooded sweatshirt.

Arena was placed under arrest for Retail Petit Theft pursuant to F.S.S. 812.014 3a. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10/25/14 Robert Arena committed the offense of retail theft at Wal-mart, 15017 Emerald Coast Parkway, Destin, FL. Arena took one 24 pack of Bud Light with the intent to deprive the merchant of possession, use, benefit, or full retail value

At approximately 2018 hours on 10/25/14, LPO John Sullivan observed two white males in the store. One of the males was wearing a blue t-shirt and was carry two 24 packs of Bud Light and a bag of Doritos chips. The second male, later identified as the defendant Robert Arena, was wearing a white zip-up hooded sweatshirt and was carry a 24 pack of Bud Light. Both subjects walked passed all points of sale and towards the exit. They walked passed the first security system and were in between the double door exits with the merchandise in hand. Sullivan approached them and identified himself. Arena placed his pack of Bud Light down on the ground and ran out of the store resisting Sullivan's efforts to detain them.

I viewed surveillance footage of the subjects. Arena was wearing a white zip-up hooded sweatshirt with a black stain on the left front pocket along with khaki shorts. In the video you can see he had brown hair and was a thin white male.

Arena was located at Waffle House, 1067 U S Highway 98, at approximately 2130 hours. He was wearing a white zip-up hooded sweatshirt with the same black stain on the left front pocket and khaki shorts. He was detained and Sullivan completed a show-up. Sullivan positively identified Arena as one of the males who were in Wal-mart stealing the Bud Light cases.

Post Miranda, Arena admitted to being in Wal-Mart with his friend Garrett Hamilton. He was shown photographs of the two subjects described by Sullivan and admitted to being the subject in the white zip-up hooded sweatshirt.

Arena was placed under arrest for Retail Petit Theft pursuant to F.S.S. 812.014 3a. This offense occurred in Okaloosa County where I am a sworn law enforcement officer.

On 10/25/14 Garret Hamilton committed the offenses of resisting a retail merchant, retail theft, and fleeing and eluding. These offenses occurred at Wal-Mart, 15017 Emerald Coast Parkway, Destin, FL.

At approximately 2018 hours, LPO John Sullivan observed two white males in the store. One of the males, later identified as the defendant Garrett Hamilton, was wearing a blue t-shirt and was carry two 24 packs of Bud Light, a bag of Doritos chips and a box of fried chicken. The second male, later identified as co-defendant, Robert Arena, was wearing a white zip-up hooded sweatshirt and was carry a 24 pack of Bud Light. Both subjects walked passed all points of sale and towards the exit. They walked passed the first security system and were in between the double door exits with the merchandise in hand. Sullivan approached them and identified himself. Hamilton, after committing theft of property, resists the reasonable effort of the merchant to recover the property or cause the individual to pay for the property. He exited the store with one 24 pack of Bud Light after dropping the rest of the merchandise in between the exits. The total value of all merchandise was \$70.71.

Sullivan positively identified Hamilton through prior encounters with him from Wal-Mart.

He is then seen by witness, Danielle Bentley, and her husband, John Bentley, exiting the store towards a 2002 Buick Rendezvous bearing FL K546IE. He entered the driver's seat with the 24 pack of Bud Light in his lap and drove around the parking lot a few times. Arena never re-entered the vehicle.

D/S Mitchell Landis was in the area and observed the vehicle traveling east on Emerald Coast Parkway. He attempted an investigative traffic stop by activating his marked patrol vehicle's emergency lights. The vehicle willfully refused to stop by accelerating rapidly, recklessly cutting off other vehicles, running over medians, and attempting to flee and elude D/S Landis.

These offenses occurred in Okaloosa County and are pursuant to F.S.S. 812.015(6) Resisting a Retail Merchant, F.S.S. 812.014(3)(a) Retail Theft, and F.S.S. 316.1935(2) Fleeing and Eluding.
