## DESTIN RESIDENT CHARGED WITH DOMESTIC VIOLENCE AGGRAVATED ASSAULT



A Destin man has been charged with aggravated assault with a deadly weapon without intent to kill in connection to a domestic violence incident Thursday morning.

57-year old Cyron Marler of 528 Kelly Street was taken into custody following an investigation that began with a 9-1-1 call about a reckless driver on Kelly Street around

7:30 a.m. A witness says she saw the victim, identified as Deborah Marler, jump out of the way of a Chevy Silverado truck as it drove towards her. The witness says the truck then went into the street, nearly hitting another vehicle.

Deborah Marler told investigators her husband, Cyron Marler, got angry during a discussion and she went out to move her car so he could leave. She says he had backed his truck onto the lawn and hit a palm tree. She said as she was walking between the house and driveway, she heard him "gas it" as he was heading towards her. She says she tried to jump out of his way as he drove forward and sped away.

Deputies who responded found two sets of acceleration marks at the scene.

## [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/09/14 I responded to a reckless vehicle, after further information from dispatch, a possible domestic disturbance, at 528 Kelly St. Destin, Florida, 32541.

Upon arrival I interviewed Cyron Eugene Marler (defendant), who stated he and his wife, Deborah Lynn Marler (victim), were having an amicable conversation when they began arguing. He attempted to leave his residence, however, Deborah was blocking him from leaving. Cyron stated he backed onto the lawn and proceeded to drive forward and around Deborah and onto Kelly St.

I interviewed Deborah who acknowledged that she and Cyron were having an amicable conversation when they began arguing, Cyron became angry and left the residence to go to work. Deborah went outside to move her vehicle which was parked behind Cyron's vehicle. When she went outside she saw Cyron had backed onto the lawn and struck a sago palm tree. Deborah stated she was between the house and her vehicle when she heard Cyron "gas it", spinning the vehicle's tires, and accelerating toward her causing her to jump out of the way.

I then interviewed Brenda Petersen, the witness, who stated she was riding her bike when she observed the victim, in her pajamas, jumping out of the way of the defendant's truck as it drove toward her. The witness further stated the defendant then sped out of the driveway, across the sidewalk, and onto Kelly St where he almost struck another vehicle. Petersen then made contact with the victim who was visibly shaking and stated "he's so angry all of the time."

# COPY

My investigation of the scene began with the 2005 silver Chevy Silverado pick up truck. I observed a flat tire on the left rear of the truck, and green foliage and a few palm tree branches on the left rear of the vehicle from the wheel well to the taillight. There were two sets of acceleration marks. One set from the top east side to the west side of the driveway and across the front yard where a sago palm tree is located. The second set of acceleration marks were from the west side of the driveway beginning at the edge of the grass and cement. They continued across the driveway toward the east, onto the grass and cement sidewalk between 528 and 526 Kelly St. The sidewalk had what appeared to be a fresh chip on the southern edge in the same area the left side tire marks crossed the concrete. The tire marks then continued to the west on Kelly St for approximately 75 feet. After further observation of the flat tire, I observed the rim of the tire was nicked. The rim around the dent was dirty, however, the cut into the rim was clean.

The defendant Cyron Marler and the victim, Deborah Marler, are married and live in the same single family dwelling making this incident a domestic violence situation.

Based on my investigation, I have reason to believe and do believe the defendant, Cyron Eugene Marler, did violate of F.S.S. 784.02.1a, Aggravated Assault (DOMV) with a deadly weapon, by driving his vehicle toward his wife at a high speed and reckless manner, causing her to jump out the way in a fearful reaction. This offense occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
