FIGHT ENDS WITH CRESTVIEW MAN IN CRITICAL CONDITION



A fight between two Crestview men just before midnight last night has left one of the participants unconscious and unresponsive in a Pensacola hospital. 32-year old Doug Dockery was taken to Sacred Heart Hospital with head injuries.

The Okaloosa County Sheriff's Office has charged 40-year old Martin McDonald of 6103 Magnolia Lane with aggravated battery.

Witnesses say the pair had been drinking for several hours prior to the fight at a friend's home at 401 Cooper Street. They say McDonald got upset with Dockery and began shoving his head into the wall. He then threw Dockery on the ground and began punching him in the head. When Martin left, Dockery tried to follow him. He walked down the street calling for help. Deputies found Dockery on his back in the front yard of 418 Cooper Street. He was covered in blood and having difficulty breathing.

Martin was located on East Robinson Avenue. He told investigators Dockery had taken a swing at him so he hit him back. Martin had no visible injuries.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 09/22/14 deputies responded to a call of a disturbance located at 401 Cooper Street, Crestview, FL. Upon arrival the victim of this incident who is identified as Douglas Dockery was located at 418 Cooper Street, where he went for help after the fight. On the arrival of this investigator the victim was on his back in the front yard of 418 Cooper unresponsive and breathing shallow, covered in blood. There were no outright signs of lacerations, but the victim had a small contusion on the right side of his head just to the rear of his right ear.

Dockery was transported by Okaloosa County EMS to Sacred Heart Hospital, Pensacola, for further treatment. This Investigator made contact with Inv. Stevenson who responded to Sacred Heart to check on the status of the victim. This Investigator was called by Stevenson and Stevenson advised the victim, Dockery, is now unconscious, unresponsive and on a ventilator. He was being transported to the Intensive Care Unit as we were speaking.

I was able to speak with the defendant in this case, identified as Martin McDonald where he was being detained by his truck in front of 720 E Robinson Avenue, Crestview. At the time of the contact, McDonald was exiting the residence and contacted law enforcement. There is a 1997 red Ford F-150 pickup truck bearing FL Tag 6628PM in front of the residence which is registered to the defendant. McDonald was advised of his rights as per Miranda and agreed to come to the North District Office for an interview.

Once at the North District Office, McDonald stated that he was at a friend's house and the victim whose name he did not know was also there. I asked how they got together and he stated he took the victim fishing all day today. I asked him what happened and he stated that he went into the room the victim was in, which is a laundry room converted into a bedroom and closed the door to talk to him and the victim took a swing at him so he hit him back a few times and then he left. There were no new injuries noted to McDonald, all of his injuries were old and according to him work related small lacerations and abrasions.

During the course of this investigation Cassie Brown gave a sworn statement that she was present when the disturbance occurred in the kitchen by the bar. She advised that McDonald was beating Dockery in the face and then slammed his head into the wall. On examination of the crime scene there is a hole in the wall with a splattering of blood around the hole.

McDonald was pulled off the victim and he then left getting into his vehicle to leave. At this time Dockery followed him out of the house and then to the vehicle where a second altercation occurred.

Based on the fact that McDonald did strike the victim multiple times and beat his head against the wall, and this leading to the victim being found unconscious and presently at Sacred Heart hospital on a ventilator; this Investigator has reason to believe and does believe that Martin McDonald did commit the crime of Aggravated Battery. This offense did occur in Okaloosa County, Florida.
