OCSO NABS CAR BURGLAR IN THE ACT



Okaloosa County Sheriff's deputies caught a car burglar in the act early this morning but the suspect tried to make a quick getaway.

A witness called the OCSO after spotting a suspicious man trying to get into parked cars at Chez Elan apartments on Racetrack Road shortly before 2 a.m.

Tuesday.

Deputies set up a perimeter. When they approached the man, he took off running, dropping a backpack found to contain a mini flashlight, screwdriver, other tools and what turned out to be stolen items.

28-year old Channing Taylor of Navarre was taken into custody after a brief foot chase.

Taylor is charged with burglary, possession of burglary tools, petty theft, resisting an officer without violence, and providing a false name to law enforcement.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On September 30, 2014 at approximately 0142 hours the defendant identified as Channing Dewayne Taylor was observed by a witness entering a red vehicle and pulling on door handles. The witness described the defendant as a black male wearing all black carrying a bag. As deputies arrived the defendant was observed by Sgt. C. Rewis entering additional vehicles with the intent of removing property. I approached the defendant while he was actively inside a vehicle. Upon the sight of law enforcement the defendant fled and deputies gave chase ordering the defendant to stop. During his flight the defendant shed a backpack containing property which did not belong to him as well as a mini flashlight, screwdriver and miscellaneous tools which would facilitate burglary. During flight the defendant remained in sight of law enforcement and was captured after approximately 400 yards. Upon his arrest and after being advised of his Miranda rights from a prepared text the defendant provided false name to deputies.

Based upon the above information I have reason to believe and do believe Channing Dewayne Taylor did commit the following offenses: Burglary to a conveyance (2) counts, petit theft (2) counts, possession of burglary tools, resist officer without violence and providing false name while under arrest to wit: burglarizing at least (2) vehicles taking property from within, having tools to facilitate burglary, fleeing from deputies and giving a false name. Theses are in violation of F.S.S. 810.02(4), 812.014, 810.06, 843.02 and 901.36(1) respectively. These violations occurred within Okaloosa county, FL where your affiant is a sworn law enforcement officer.
