SEARCH WARRANT UNCOVERS DRUGS, GUNS, AND CASH



A burglary call at a Fort Walton Beach apartment complex yesterday eventually led to a search warrant that uncovered drugs, firearms, and more than 82-thousand dollars in cash. The Okaloosa County Sheriff's Office responded to a call of a burglary to a residence at Madison Parc Apartments, 1851 Stella Lane, Apartment 532 April 21st. Once on scene, evidence of forced entry into the apartment was observed.

During the investigation, members of the Sheriff's Office Narcotics Unit obtained a search warrant for the residence as well as a vehicle that arrived on scene. The driver of the vehicle, 25-year old Andres A. Barrios, was identified as the occupant of the apartment as well. A subsequent search of his apartment revealed two pounds of marijuana, two firearms, miscellaneous drug paraphernalia, controlled substances and U.S. Currency totaling \$82,373.00. A search of the vehicle revealed approximately 20.5 pounds of additional marijuana along with a stolen firearm.

Barrios is charged with possession of marijuana with intent to distribute, carrying a concealed firearm, possession of a firearm during commission of a felony, grand theft of a firearm, possession of a controlled substance without a prescription, and possession of drug paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On April 21, 2015, the Okaloosa County Sheriff's Office Narcotics Unit executed a search warrant at a residence located at 1851 Stella Lane, Apartment 532, Fort Walton Beach, Okaloosa County, Florida. This search warrant was approved by Assistant State Attorney Stephen Bernhardt. The search warrant was then read and signed by the Honorable Patricia Grinsted.

Prior to the execution of the search warrant the Defendant, Andres A. Barrios, was advised of his Miranda rights.

Principal

During a search of the residence, suspected marijuana was located in various locations throughout the residence. The total weight of the marijuana collected from within the residence weighed approximately 2 pounds. The suspected marijuana was field tested and rendered a presumptive positive response for the presence of THC.

Also located in the residence were numerous items of paraphernalia to include; vacuum sealers, unused vacuum seal bags, cut vacuum seal bags that previously contained marijuana, marijuana grinder, marijuana smoking devices, digital scales, and other storage containers that contained suspected marijuana.

Located in a kitchen drawer were 12 suspected Alprazolam pills. The Defendant admitted that he did not have a prescription for the pills and added that he takes them to help him sleep. These pills were tentatively identified as 2mg Alprazolam based on the pill markings using an online drug information database.

Also on April 21, 2015, a search warrant was also issued for a white 2013 Ford Explorer sport utility vehicle, bearing Florida tag 830 RRN. This search warrant was approved by Assistant State Attorney Stephen Bernhardt. The search warrant was then read and signed by the Honorable Patricia Grinsted. This vehicle was parked in the parking lot in front of the apartment building located at 1851 Stella Lane, Fort Walton Beach, Okaloosa County, Florida, Prior to preparing the search warrants, the Defendant arrived at the residence operating this vehicle.

During a search of the vehicle a Fed Ex package was located in the rear of the vehicle. During a search of the package, approximately 20.5 pounds of suspected marijuana was located. This marijuana was field tested and rendered a presumptive positive response for the presence of THC.

A semi-automatic .40 caliber Smith & Wesson SD 40 handgun with serial number DUZ9429 was located concealed under the driver's seat. The handgun was not securely encased in a holster. After running an FCIC/NCIC check, it was determined this handgun was reported stolen out of Okaloosa County, Florida on May 14, 2013.

During the post Miranda interview, the Defendant admitted that all the contraband located throughout the residence and vehicle belonged to him. The Defendant stated he had purchased the firearm "street side" for \$200.00. The Defendant could not identify the person who allegedly sold him the firearm. The Defendant admitted to placing the firearm under the seat of the vehicle upon sight of law enforcement when he arrived in the parking lot of his residence.

Based on the aforementioned information, your Affiant has reason to believe the Defendant, Andres A. Barrios, did violate F.S.S. 893.135(1a2) Possession of Marijuana with Intent to Distribute, F.S.S. 893.13(6a) Possession of a Controlled Substance without Prescription, F.S.S. 812.014(2c5) Grand Theft of a Firearm, F.S.S. 790.01(2) Carrying a Concealed Firearm, F.S.S. 790.07(2) Possession of a Firearm During the Commission of a Felony Offense, and F.S.S. 893.147 Possession of Drug Paraphernalia. These offenses did occur in Okaloosa County, Florida.
