## **DEPUTIES NAB BURGLARY SUSPECT AND RECOVER STOLEN GUNS**



A Mary Esther woman came home Sunday to find a man running out of her house with some of her property, including two handguns. At some point, the thief dropped the stolen goods. Responding units from the Okaloosa County Sheriff's Office set up a perimeter and brought in K-9 units to start a track. During the search, a deputy who made contact with a citizen noticed the man had numerous scratches on him consistent with running through brush. An eyewitness brought to the scene identified the individual as the suspect. Deputies were able to locate property stolen from at least three separate area burglaries, including three firearms. Charges against 27-year old Jeremy Wayne Nichols of 713 Creekwood Drive in Mary Esther include burglary, grand theft, possession of a firearm by a convicted felon, petty theft, and criminal mischief.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 4-5-15, I responded to 306 Friar Tuck Rd, Mary Esther Florida in reference to a Burglary.

The victim, Linda B. Smith, returned to her residence and discovered the defendant, later identified as, Jeremy Wayne Nichols exiting the side door with property taken without authorization.

The defendant was then observed by the victim, jumping the fence and fleeing onto the property behind the abovementioned location. Several citizens witnessed the defendant fleeing and updated responding patrol units with a description and last known location. As a perimeter was established, the victim advised that two handguns were taken during the burglary.

Information provided by a witness advised that the defendant had fled onto an abandoned lot and had possibly dropped some of the stolen property. I proceeded to the location and discovered a black tennis shoe possibly worn by the defendant. There was also a white plastic garbage bag with several pieces of property described by the victim which was taken from her residence. A closer observation revealed two handguns which matched the description given by the victim.

K9 Deputies arrived and established a track of the defendants' last known direction of travel. While tracking, the perimeter was reestablished to cover a larger area.

D/S Haggan repositioned and made contact with a citizen who stated she witnessed a white male leave a residence across the street from hers earlier. The male was wearing clothing described by the victim. The citizen stated she witnessed the same male return a short time later carrying what appeared to be a blue cloth type of bag full of items. Based on the description, D/S Haggan observed a male matching the description of the citizen and began a consensual conversation. While conversing, D/S Haggan observed what appeared to be marks and fresh injuries consistent with injuries obtained while fleeing from law enforcement through thick brush and bushes.

As other perimeter units arrived, the defendant attempted to leave. The defendant, due to his suspicious actions, was detained and Miranda Rights were read. The defendant verbally acknowledged an understanding. The defendant spontaneously stated that he was "sorry" but did not specify or clarify what he was referring to. During this timeframe, multiple calls were received by OCSO dispatch in reference to newly discovered burglaries.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 4-5-15, I responded to 414 Little John Rd, Mary Esther Florida in reference to a Burglary.

The victim, Amanda J. O'Malley, returned to her residence and discovered unauthorized entry and property taken without authorization.

The defendant later identified as, Jeremy W. Nichols was observed by witnesses, jumping fences and fleeing. Several citizens witnessed the defendant fleeing and updated responding patrol units with a description and last known location. A perimeter was established.

Information provided by a witness advised that the defendant had fled onto an abandoned lot and had possibly dropped some of the stolen property. I proceeded to the location and discovered a black tennis shoe possibly worn by the defendant. There was also a white plastic garbage bag with several pieces of property.

K9 Deputies arrived and established a track of the defendants' last known direction of travel. While tracking, the perimeter was reestablished to cover a larger area.

D/S Haggan repositioned and made contact with a citizen who stated she witnessed a white male leave a residence across the street from hers earlier. The male was wearing clothing described by the victim. The citizen stated she witnessed the same male return a short time later carrying what appeared to be a blue cloth type of bag full of items. Based on the description, D/S Haggan observed a male matching the description of the citizen and began a consensual conversation. While conversing, D/S Haggan observed what appeared to be marks and fresh injuries consistent with injuries obtained while fleeing from law enforcement through thick brush and bushes.

As other perimeter units arrived, the defendant attempted to leave. The defendant, due to his suspicious actions, was detained and Miranda Rights were read. The defendant verbally acknowledged an understanding. The defendant spontaneously stated that he was "sorry" but did not specify or clarify what he was referring to. During this timeframe, multiple calls were received by OCSO dispatch in reference to newly discovered burglaries.

A show up was conducted and the defendant was positively identified as the male seen by several witnesses fleeing the scene. While detained, contact was made with a female companion who was present and resides with the defendant. Consent to search was obtained. Items and property described by victim were discovered inside the residence.

Based on the evidence of my investigation I have reason to believe and do believe the defendant, Jeremy Wayne Nichols violated F.S.S 810.02(2b) Burglary, F.S.S 812.014(3a) Theft and F.S.S 790.23.1a Possession of a Firearm. This
