TRIO OF TEENS CHARGED IN CAR BURGLARY AND BUNGLED GETAWAY ATTEMPT IN STOLEN CAR

Three teenagers are charged in connection with a car burglary that led to a chase and foot pursuit Monday.

Deputies were called to the Tom Thumb Convenience store at 1096 North Beal Parkway around 9 a.m. yesterday after a man reported that a teen went into his car while the car owner was inside paying for gas.

Deputies spotted the suspect vehicle, a Lincoln Town Car, several blocks away. The driver, later identified as 18-year old Jeffrey Lamar Brown Junior of Crestview, refused to stop and sped away at a high rate of speed. During a pursuit, Brown intentionally hit the front end of a deputy's marked patrol car. Brown continued to try to get away and crashed into a Waste Management garbage truck at Pier One Apartments on Pelham Road. Another deputy swerved to avoid Brown's vehicle. His patrol car was struck on the right front corner.

Brown fled but was caught after a short foot pursuit.

Two passengers were also detained.

While investigating the incident, the owner of the suspect car called the Crestview Police Department to report it had been stolen.

Brown is charged with fleeing and eluding, grand theft of a motor vehicle, burglary to a conveyance, and aggravated battery on a law enforcement officer.

The passengers, 19-year old Darius Wilks of Crestview and 18-year old Vanessa Forgione, are charged with grand theft of a motor vehicle and burglary to a conveyance.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On Monday August 03, 2015 approximately 0855 hrs, Lesley F. Fonseca reported his vehicle had been burglarized at the Tom Thumb Convenience store at 1096 N Beal Parkway, Fort Walton Beach, Florida. Fonseca reported two black males and two white females were in the parking lot andwere seen near his vehicle. A witness stated one of the males had been in Fonseca's car. The suspects left in a maroon Lincoln Town Car.

Deputy Robert Speakman observed the suspect vehicle several blocks away and notified your affiant who attempted a traffic stop. The driver, Jeffrey Lamar Brown Jr., did not stop and fled from law enforcement with their lights and sirens activated. The suspect vehicle continued to evade law enforcement at a high rate of speed. During the pursuit, Brown intentionally struck the front end of Deputy Speakman's marked patrol vehicle in an attempt to evade custody. Brown continued to flee without disregard for the safety of persons and property.

Brown crashed the suspect vehicle into a garbage truck at the Pier One Apartments, 211 Pelham Road, Fort Walton Beach, Florida. Brown immediately fled on foot and was detained after a short foot pursuit. Darius Deon Wilks and Vanessa Marie Forgione were passengers and were detained while still in the vehicle. Fonseca was transported to the scene of the crash and was able to positively identify all three as those persons he saw near his vehicle at the time of the burglary.

While the incident was in progress, the owner of the suspect vehicle, Ila Hester, contacted the Crestview Police Department and reported her car had been stolen. She provided a sworn affidavit of complaint in which she indicated the last time she saw her vehicle was on Saturday, August 1, 2015. She did not give anyone permission to take, remove, or use the vehicle. Darius Wilks made a post Miranda statement that he did not know the driver and had just been given a ride. On Jeffrey Brown's Facebook page a picture is posted which shows Brown and Wilks in front of the stolen vehicle. The picture was posted approximately 9 hours earlier and both Brown and Wilks are wearing the same clothing in the photograph as they were wearing when arrested. During his post Miranda interview, Brown stated he and Wilks are "homeboys", meaning they are friends and know each other well.

Vanessa Forgione, in her post Miranda interview, admitted to being with Brywn and Wilkes when they burg larized vehicles at the Tom Thumb store and at the Shell Gas Station located at Green Acres Blvd and Green Acres Rd. She stated today was the first time she had burglarized cars and stated she took the Facebook photo of Brown and Wilks. She also indicated she had been told the car was "hot" although she said she didn't know if that meant the vehicle was stolen or the engine was overheating. She also indicated the plan today was for her to pawn items, specifically a knife and a laptop (which she believed to be stolen) at a local pawn shop because she was the only one with identification. When initially detained, Wilks had been in possession of a large military type knife.

Based on the above information I have reason to believe and I do believe that Jeffrey Lamar Brown, Jr did commit the offense of Fleeing and Eluding, Burglary to Conveyance, Aggravated Battery on LEO and Grand Theft of a Motor Vehicle in violation of FSS 810.02, 784.07.2d, 316.1935.3A, 812.014 and respectively. This offense did occur in Okaloosa County, Florida.

Deputy Robert Speakman observed the suspect vehicle several blocks away and notified your affiant who attempted a traffic stop. The driver, Jeffrey Lamar Brown Jr., did not stop and fled from law enforcement with their lights and sirens activated. The suspect vehicle continued to evade law enforcement at a high rate of speed. During the pursuit, Brown intentionally struck the front end of Deputy Speakman's marked patrol vehicle in an attempt to evade custody. Brown continued to flee without disregard for the safety of persons and property.

Brown crashed the suspect vehicle into a garbage truck at the Pier One Apartments, 211 Pelham Road, Fort Walton Beach, Florida. Brown immediately fled on foot and was detained after a short foot pursuit. Darius Deon Wilks

and Vanessa Marie Forgione were passengers and were detained while still in the vehicle. Fonseca was transported to the scene of the crash and was able to positively identify all three as those persons he saw near his vehicle at the time of the burglary.

While the incident was in progress, the owner of the suspect vehicle, Ila Hester, contacted the Crestview Police Department and reported her car had been stolen. She provided a sworn affidavit of complaint in which she indicated the last time she saw her vehicle was on Saturday August 1, 2015. She did not give anyone permission to take, remove, or use the vehicle. Darius Wilks made a post Miranda statement that he did not know the driver and had just been given a ride. On Jeffrey Brown's Facebook page a picture is posted which shows Brown and Wilks in front of the stolen vehicle. The picture was posted approximately 9 hours earlier and both Brown and Wilks are wearing the same clothing in the photograph as they were wearing when arrested. During his post Miranda interview, Brown stated he and Wilks are "homeboys", meaning they are friends and know each other well.

Vanessa Forgione, in her post Miranda interview, admitted to being with Brown and Wilkes when they burglarized vehicles at the Tom Thumb store and at the Shell Gas Station located at Green Acres Blvd and Green Acres Rd. She stated today was the first time she had burglarized cars and stated she took the Facebook photo of Brown and Wilks. She also indicated she had been told the car was "hot" although she said she didn't know if that meant the vehicle was stolen or the engine was overheating. She also indicated the plan today was for her to pawn items, specifically a knife and a laptop (which she believed to be stolen) at a local pawn shop because she was the only one with identification. When initially detained, Wilks had been in possession of a large military type knife.

Based on the above information I have reason to believe and I do believe that Darius Wilks did commit the offense of Burglary to Conveyance and Grand Theft of a Motor Vehicle in violation of FSS 810.02.4b and 812.014.2c6, respectively. This offense did occur in Okaloosa County, Florida.
