**OKALOOSA MAN CHARGED WITH AGGRVATED BATTERY
AFTER BEATING VICTIM WITH METAL BATON**

A Fort Walton Beach man says he was beaten unconscious by a man wielding a metal baton yesterday morning following a confrontation at an Okaloosa Island nightspot.

The Okaloosa County Sheriff's Office has charged 31-year old Christian Aponte Pagan with aggravated battery with a deadly weapon.

35-year old victim Jeremy Bullock and his girlfriend were leaving the Red Rose Gentleman's Club at 106 Santa Rosa Boulevard around 5:30 a.m. when the girlfriend, Suzanne Cicchetti, said a white truck nearly ran them over. Cicchetti says Bullock yelled at the driver, who then stopped the truck, and got out, grabbing a baton from inside the vehicle. She says she told him it was ok and they didn't have to fight but the man, later identified as Aponte, struck her in the face with the baton. Cicchetti says Bullock jumped towards Aponte to defend her and Aponte struck him multiple times with the baton, causing him to lose consciousness temporarily.

Responding deputies say Cicchetti had swelling and bruising on her right cheek and Bullock had a large laceration to his lip, facial swelling, and swelling on his chest, left knee, and back of the neck.

Aponte claims Bullock kicked his truck and that he got out with the baton in self-defense. He denies striking Cicchetti.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On December 03, 2015 the defendant, Christian Aponte Pagan was at the incident location of 106 S Santa Rosa Blvd. (Red Rose Gentleman's Club) Okaloosa, Island Florida.

When the defendant was leaving the parking lot the male victim kicked the rear passenger door of his truck. The defendant grabbed a black metal asp from his truck to confront the victim's about the damaged truck. The defendant got out of his truck with weapon in hand, and a fight ensued. The defendant struck both victim's with the asp until the male victim was left unconscious.

Both victim's had injuries consistent with being hit with an asp. The female victim had a red welt with bruising across her right cheek while the male victim had a large laceration on his upper lip, swelling on his lip. The male also had red marks on his back, the back of his neck, his chest and both knees.

The defendant admitted to getting out of his vehicle with the asp, but in self defense. The defendant also denied striking the female victim at any point.

Based on the evidence of my investigation I have reason to believe and do believe the defendant, Christian Aponte Pagan knowingly struck two victim's with a weapon during an altercation. This is a direct violation of F.S.S. 784.045(1A2); Aggravated Battery w/ deadly weapon. This incident occurred in Okaloosa County, Florida where I am a sworn Law Enforcement Officer.
