**CRESTVIEW MAN FACING CHARGES IN CONNECTION
WITH AIRSOFT GUN INCIDENT AT BUS STOP**



A Crestview man was arrested on a charge of aggravated assault with a firearm and child abuse Wednesday after pointing what turned out to be a very realistic looking airsoft gun at two Antioch Elementary school children.

A call for an armed disturbance came in around 4 p.m. January 14th from a bus driver who was dropping off students at a stop on Jenkins Road and Regan Drive.

The driver said a man drove up and pointed a gun at an 8 year old girl and 9 year old boy who had just gotten off the bus.

The girl said she heard two “pop” noises and believed the man was shooting at her so she ran back to the bus. She told deputies she was scared and could not stop shaking.

The 9 year old boy also said he heard what he thought were guns shots as he was running away. He was located safe at his home.

The bus driver said the man picked up two other students and drove away.

Okaloosa County Sheriff’s Office deputies tracked the individual to the front porch of a home on Jenkins Drive where they found him in possession of a Ruger P345 “Airsoft” gun.

30-year old Adolfo Roura III of 4285 Jenkins Road denied pointing the gun at the children and said he was shooting at cans in the wood line. Deputies say they did not observe any cans inside the wood line in that location.

Roura is now charged with aggravated assault and child abuse.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 01/14/2015 at approximately 1600 hours, I responded to 1881 Regan Dr, Crestview Florida 32536 in reference to an armed disturbance. An investigation was conducted and yielded the following information:

Laura Cruse, Okaloosa County School District Bus operator, was stopped at the intersection of Jenkins Rd and Regan Dr letting children depart from school bus 97-8. Laura said as the children departed, [REDACTED] (8 YOA) and [REDACTED] (9 YOA), she observed [REDACTED] run into the woods directly across from 1881 Regan Dr. As [REDACTED] ran into the woods she observed a white male, later identified as Adolfo Roura III, sitting inside a gold-colored Oldsmobile passenger car display a firearm in which she described as a "black gun", pointing the firearm into the woods and near [REDACTED]'s location. Laura said Adolfo drove the vehicle forward, west, on Regan Dr, stopped and pointed the firearm again into the wood-line south of Regan Dr. Roura drove west bound on Regan Dr towards Moon Rd. There were 2 other juveniles on the bus when this incident occurred.

[redacted] (8 YOA) stated she exited the bus and walked into the wood-line south of 1881 Regan Dr to use the restroom. She said as she walked into the woods a white man inside a silver car pointed a "black gun" at her, in which she heard 2 "pop" noises she believed to be gunshots. [redacted] said she thought the man was shooting at her so she ran back to the bus. [redacted] said she was scared and could not stop shaking. [redacted] said the man was white, with brown hair and she believed he was wearing something with a blue sleeve.

[redacted] (9 YOA) said he exited the bus at his bus stop located at Regan Dr. and Jenkins Rd. As he got off the bus he observed a white male in a white colored sleeveless t-shirt, sitting in a "granny car" holding a pistol on the arm rest between the two front seats. Jackson said he could not tell the color of the firearm. [redacted] ran up Jenkins Rd. As he was running he said he heard "some shots" he believed to be gun shots.

[redacted] (11 YOA) was inside the bus when the incident occurred. [redacted] said she saw a blue sleeve stick out of a "silver car" holding a "black gun". [redacted] said she yelled out to the bus driver, Laura, and told her there was a man with a gun. [redacted] said she was unsure if the male fired the weapon because she was inside the bus and could not hear anything.

[redacted] (7 YOA) was also inside the bus during the incident. [redacted] said she saw "the man with the black gun" also.

Paula Perry, resident of 1881 Regan Dr, said she overheard 3 "pop" noises while sitting outside of her residence between the times after the first school bus arrives and the times Laura's school bus arrived on scene. Paula did not think much of the noises until she said her daughter noticed [redacted] getting back onto the school bus late in the afternoon. Paula said when she walked around to the front yard of her residence she noticed a silver or gold passenger car driving away on Regan Dr. towards Moon Rd. Paula said she believed this man to be "Al" who she believes resides at "the last house on the left of Jenkins Rd".

Based on the victim and witness statements and information about the suspect deputies located the vehicle matching the description at 4285 Jenkins Rd. The suspect was located and identified as Adolfo Roura III. He was taken into custody, and post Miranda stated he was sitting at the bus stop on Regan Dr and Jenkins Rd awaiting for his daughters to get off the bus. While waiting Adolfo said he used his air soft gun to shoot at cans in the wood-line. Adolfo said he did not point the air soft gun at anyone nor did he shoot towards any children. A black "Ruger" P345 Air Soft gun was located on Adolfo's person. This matches the descriptions given by the victim and multiple witnesses.

During the assessment of the scene, I could not observe any cans inside the wood line where [redacted] was standing, from the street, as Adolfo states.

Adolfo did have in his possession what appeared to [redacted] as well as other witness to be a "black gun". [redacted] Laura, [redacted] all said they saw Adolfo point the weapon outside the vehicle and in the direction of [redacted] location. Laura was able to positively identify Adolfo as the male inside the vehicle after conducting a show-up. Adolfo further stated he did point the weapon into the woods however stated he did not point the weapon at any person; Knowing children were present as he stated he was awaiting his two daughters.

Based on this information I do have probable cause to believe the defendant, Adolfo Roura III, did commit the offense of Aggravated Assault in violation of F.S.S. 784.021(1a1) and Child Abuse in violation of F.S.S. 827.03(2c). He was taken into custody and transported to Okaloosa County Department of Corrections. This incident occurred in Okaloosa County Florida.
