

CAR BURGLARY INVESTIGATION LEADS DEPUTIES TO STOLEN GUNS, DRUGS, AND THOUSANDS IN CASH



An investigation into a car burglary led Okaloosa County Sheriff's Office deputies to the recovery of stolen goods and firearms Friday.

A car burglary involving a stolen iPad took place early this morning outside a home on Twin Bay View in Fort Walton Beach.

The investigation led OCSO deputies to 104 Harbeson

Avenue. A search warrant was executed in apartment A at that address and deputies recovered the stolen iPad, stolen guns, drugs, and more than \$4000 in cash.

26-year old Felicita Dora Garcia and 26-year old David Christian Woods, both of 104 Harbeson Avenue, Apartment A, are charged with dealing in stolen property. The investigation is continuing and additional charges are pending.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On January 2, 2015, I made contact with the victim at her residence located in Okaloosa County in reference to a stolen Apple Ipad, model MC755LL/A serial# DR5HW118DJHF. The victim valued her stolen Ipad at approximately \$550. The victim stated her Ipad was stolen out of her white 2009 Toyota Tundra. The victim informed me she utilized the application "Find my Iphone" and located her stolen Ipad on Harbeson Avenue SE in the city of Fort Walton Beach.

I utilized the victim's phone and tracked the stolen Apple Ipad near the corner of Birch Street and Harbeson Avenue. While on scene at Harbeson Avenue SE, I observed a black male later identified as defendant David Woods, standing outside of 104 Harbeson Avenue SE, apartment A. I made contact with Woods and viewed the tracking log on on the "Find my Iphone" application which pin pointed the item at the same residence where Woods was located. I advised Woods I was conducting a vehicle burglary investigation and located a stolen Ipad at his residence.

I began to question Woods and he stated he had an Ipad located at his residence. Woods entered his residence and retrieved the Ipad. I activated the alarm sound from the "Find my Iphone" application and it made an audio tone which signaled to the Ipad in Woods's possession. The Ipad was in fact the Ipad reported as stolen by the victim.

Post Miranda Right's Advisement Woods stated he bought the Ipad from a "crack head" early in the morning hours on January 2, 2015. Woods stated he didn't believe the Ipad was stolen due to the item not having a lock code. I notified Woods that the victim's information was accessible and her name was located on the programs at the home screen. Woods finally recanted his statement and notified me he believed the Ipad was stolen upon me making contact with him at his residence.

Based on the evidence which consisted of locating the stolen Ipad at 104 Harbeson Avenue, apartment A, the post Miranda Right's Advisement statement Woods made stating he believed the item to be stolen upon me making contact with him, the fact Woods possessed the stolen Ipad in which he or she knows or should have known to be stolen; David Woods was arrested for violation of Florida State Statute 812.019(1) Dealing in Stolen Property. This incident occurred in

Okaloosa County where I am a sworn law enforcement officer.
