## **DESTIN WOMAN ACCUSED OF STABBING BOYFRIEND**



The Okaloosa County Sheriff's Office has charged a Destin woman with aggravated battery domestic violence after her boyfriend suffered multiple cuts and stab wounds following a verbal argument. 31-year old Heather Michelle Hudson of 4050 Dancing Cloud Court was arrested Sunday, January 25<sup>th</sup>, at the apartment she shares with the victim.

Deputies found 31-year old Richard Sansom on his back in the complex's parking lot around 2:15 a.m. yesterday with cuts or stab wounds to his arm,

chest, left side of his neck, and left hand.

Another roommate says Hudson was angry at Sansom because he wasn't paying attention to her while all three were out at a Destin bar earlier in the night. He says when they got home, he went to his room, but then heard glass breaking and Sansom shouting for him to call 9-1-1.

Sansom was treated at Sacred Heart Hospital in Walton County and released.
