

### **OCSO SEIZES HEROIN, ARRESTS THREE**



A joint investigation led to the January 6<sup>th</sup> arrests of a trio of suspected heroin distributors in Fort Walton Beach and the seizure of more than thirty grams of the drug.

The Okaloosa County Multi-Agency Drug Task Force, Florida Department of Corrections office of Probation and Parole, and the U.S. Marshals Service Florida Regional Fugitive Task Force took part in the investigation.

Their combined efforts resulted in the seizure of methamphetamine, controlled pharmaceutical drugs, marijuana, more than 30 grams of heroin, ammunition possessed by convicted felons, and approximately \$35,000 in cash.

Corey Baker

41-year old Corie Dewyane Copeland of 7 Miller Street is charged with trafficking in heroin, possession of methamphetamine, tampering with evidence, possession of marijuana and possession of drug paraphernalia.

47-year old Ezekiel Oneil Mason of 115 Koon Street is charged with possession of ammunition by a convicted felon, possession of marijuana, possession of drug paraphernalia, and felony violation of probation.

38-year old Corey Eugene Baker of 361 Kepner Drive is charged with possession of heroin with intent to sell.

Heroin is sold to the end user in  $1/10^{\text{th}}$  gram units for between \$30 and \$50 in the Fort Walton Beach area.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 6, 2015 I, along with members of the United States Marshal Service and the Okaloosa County Sheriff's Office, arrested the defendant, Corie Dewayne Copeland, at his residence of 7 Miller Street, Fort Walton Beach, Okaloosa County, Florida. Forced entry had to be made into the residence as the defendant refused to come to the door. Once inside, officers located Copeland in the bathroom where he still refused to surrender. Officers could hear the toilet

flushing inside the bathroom at this time. Eventually, Copeland opened the door and came out. His clothing and hands were wet when he was taken into custody.

A search warrant was subsequently obtained for the residence after drugs and drug paraphernalia were observed in plain view inside the residence. Judge William Stone reviewed and signed the search warrant.

On January 6, 2015 the search warrant was executed at 7 Miller Street. During a search of the residence, approximately 2 grams of suspected methamphetamine was located in a back bedroom which did field test positive. In another room, less than one gram of suspected marijuana was located which did field test positive. Also located in the residence was a marijuana grinder and a glass methamphetamine smoking pipe.

During a search of the bathroom where Copeland was located, the toilet was removed for inspection. A plastic baggie containing approximately 30 grams of suspected heroin was located in the toilet drain and did field test positive.

Based on the aforementioned information, I have reason to believe that the Defendant, Corie D. Copeland, did violate F.S.S. 893.135(1c)1 Heroin Trafficking, F.S.S. 893.13(6a) Possession of Methamphetamine, F.S.S. 918.13 Tamper/Destroy Physical Evidence, F.S.S. 893.13(6b) Possession of Marijuana under 20 grams, and F.S.S. 893.147 Possession of Drug Paraphernalia. These offenses did occur in Okaloosa County Florida.

#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 06, 2015, your Affiant accompanied members of the Florida Department of Corrections (Probation and Parole) to 115 A Koon Street, Fort Walton Beach, Okaloosa County, Florida, for a probationary search. This residence belongs to Ezekiel MASON.

During the probationary search of the residence, probation officers located ammunition, suspected marijuana weighing approximately 26 grams (subsequently field tested positive) in a plastic bag and approximately \$15,000.00 in US currency. Per MASON's Probation Officer, Richard Pfalzgraf, both the ammunition and the suspected marijuana were a violation of MASON's probation stipulations.

Upon locating the suspected marijuana, your Affiant instructed the probation officers to stop searching the residence and advised MASON of his Miranda rights prepared text. During a post Miranda interview, MASON stated he knew he had the ammunition and claimed ownership of the suspected marijuana.

Based upon the facts of the investigation, your Affiant prepared and applied for a narcotics search warrant for MASON's residence. This narcotics search warrant was reviewed and approved by Assistant State Attorney David Stevens. This narcotics search warrant was read and signed by the Honorable William Stone.

During the execution of the search warrant law enforcement officers located a digital scale, controlled pharmaceutical medication (identified as hydrocodone per www.Drugs.com), and approximately \$20,000.00 in additional US currency.

Based on the above, your Affiant has probable cause to believe that Ezekiel MASON did violate Florida State Statutes 893.13.6(a), Possession of a Controlled Substance without a prescription (2 counts); 948.06, Violation of Felony Probation; 790.23(1a), Possession of Ammunition by a Convicted Felon; and 893.147(1b), Possession of Drug Paraphernalia.

### [STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On January 6, 2014, I was participating in a narcotics investigation that was occurring at 115 Koon Street Unit A in Fort Walton Beach, Florida. During this investigation, the Defendant, who was later identified as Corey Baker, arrived at the front door of the residence and rang the doorbell. Contact was made with Baker, who related that he had come to the residence in order to make contact with the target of the investigation.

Baker voluntarily consented to a search of his person, at which time two small clear plastic baggies containing suspected heroin were recovered from his inner most right front pants pockets.

Post Miranda, Baker admitted that the substance recovered from his pants pockets was "H," which is a known slang term for heroin. During the interview, Baker confirmed that he was referring to heroin.

Upon closer inspection of the evidence, one of the bags containing suspected heroin was broken down into six smaller bags, indicative of distribution. The suspected heroin field tested positive.

This is in violation of F.S.S. 893.13(1a)1 Possession of Heroin with Intent to Sell, and did occur in Okaloosa County, Florida.
