NORTH OKALOOSA PAIR CHARGED WITH STEALING TV'S, PITBULL



Two Holt residents have been charged with burglary and two thefts in the Laurel Hill area of north Okaloosa County.

Investigators say 25-year old Travis Monroe Adams of 220 West Highway 90 and 21-year old Myra Ellen King first went to a home at 7838 North State Road 85 around 3:45 p.m. July 13th and stole two flat screen televisions. The pair took the TV's to another home in Laurel Hill and placed them on the back porch.

Approximately two hours later deputies say Adams and King were in a blue Chevy Avalanche heading north in Laurel Hill and stopped in front of a home at 7344 North State Road 85. They entered the gated front yard and removed a brown pit bull dog named "Harley" and put him in the cab of the truck. The owner also used social media to help publicize the theft in an effort to get back her dog.

Officers with the Crestview Police Department spotted the suspect vehicle July 14th at a Crestview convenience store and OCSO Investigators arrived.

Adams and King were charged with burglary and two counts of theft.

The stolen televisions and pet were returned to the rightful owners.

On July 14, 2015 I conducted a recorded interview with the co-defendant who initially advised he didn't want to talk about it. Later in our conversation the co-defendant told me that he did not know the people that lived at the residence where the televisions were stolen from but that the defendant did. He told me that the defendant told him she knew the people that lived at the home and she had permission to take the televisions. He told me that Thompson drove them to the residence where he and the defendant approached the front door. The co-defendant told me that he never entered the residence but stayed on the front porch where the defendant entered the residence and handed him a television

_ _ to load into the truck. He told me that the defendant also removed a television as well. The co-defendant also told me that the defendant supposedly called the home owner prior to their departure and advised them they were headed that way to pick up the televisions.

I completed a recorded interview with the defendant who told me that Thompson owed her money for an electric bill and told her she could get televisions from the residence in Laurel Hill, sell them and give her the cash for the bill. The defendant told me that Thompson was the only person she spoke to in reference to the televisions. I then confronted her with the co-defendant advising that she called the home owner prior to going to get the televisions. The defendant then told me that she did call a lady named Maria who is in a relationship with the home owner and that Maria gave her permission to take the televisions. The defendant provided me with a telephone number for Maria and I contacted her. Maria told me that she did not give anyone permission to remove anything from the residence.

The televisions were recovered and returned to the victim.

These offenses did occur in Okaloosa County and are direct violations of F.S.S. 810.02(3)(b) Burglary of an Unoccupied Dwelling & 812.014(2)(c)(1) Grand Theft Value Between \$500 - \$1000.

On July 13, 2015, the defendant, Myra Ellen Adams, did commit the criminal offense of Grand Theft Property Valued Between \$300-\$1000.

On the above mentioned date the defendant was riding as a passenger in a blue Chevy Avalanche while traveling on North State Road 85 in Laurel Hill. The driver of the Avalanche, Kelly Thompson, stopped the vehicle in front of 7344 North State Road 85 where the defendant exited the vehicle, entered the gated front yard and removed a brown Pit bull dog named "Harley" and placed him inside the cab of the Avalanche. Thompson then pulled away with the defendant and the stolen Pit bull. Thompson advised that she drove the defendant and the Pit bull to the boat ramp in Milligan, Florida where the defendant had been camping in a tent.

On July 14, 2015 I conducted a recorded interview with the defendant who told me that she picked the Pit bull up as it was walking along the side of Highway 85 and she thought it was a stray.

It should be noted that photographs were taken by a witness of the blue Chevy Avalanche as it was parked at the property of the victim in this case.

The victim completed a sworn Affidavit of Complaint and advised that the Pit bull was secured inside a chained fence that the defendant had to of opened in order to get the dog. The Pit bull was valued at \$300.00.

On July 13, 2015, the defendant, Travis Monroe Adams, did commit the criminal offense of Grand Theft Property Valued Between \$300-\$1000.

On the above mentioned date the defendant was riding as a passenger in a blue Chevy Avalanche while traveling on North State Road 85 in Laurel Hill. The driver of the Avalanche, Kelly Thompson, stopped the vehicle in front of 7344 North State Road 85 where the defendant exited the vehicle, entered the gated front yard and removed a brown Pit bull dog named "Harley" and placed him inside the cab of the Avalanche. Thompson then pulled away with the defendant and the stolen Pit bull. Thompson advised that she drove the defendant and the Pit bull to the boat ramp in Milligan, Florida where the defendant had been camping in a tent.

On July 14, 2015 I conducted a recorded interview with the defendant who told me that he picked the Pit bull up as it was walking along the side of Highway 85 and he thought it was a stray.

It should be noted that photographs were taken by a witness of the blue Chevy Avalanche as it was parked at the property of the victim in this case.

The victim completed a sworn Affidavit of Complaint and advised that the Pit bull was secured inside a chained fence that the defendant had to of opened in order to get the dog. The Pit bull was valued at \$300.00.
