## **FWB TEEN ARMED WITH MILITARY STYLE RIFLE FACING MULTIPLE WEAPONS CHARGES**



A 17-year old Fort Walton Beach resident faces multiple weapons charges after a Shalimar resident says he came to his apartment yesterday and threatened him with a military style rifle loaded with nearly 100 rounds of ammunition.

The Okaloosa County Sheriff's Office has charged Kionte Jamal McGrew of 433 Woodrow Street with aggravated assault with a deadly weapon, carrying a concealed firearm, improper exhibition of a dangerous weapon, unlawful possession of a firearm, and attempting to destroy or tamper with evidence when confronted by law enforcement.

The victim says McGrew came to his apartment on 8<sup>th</sup> Avenue to confront him about a dispute and threatened him through the door.

He and other witnesses say McGrew challenged him to fight and said he was going to kill him. When the victim would not answer the door, he and witnesses say McGrew retrieved a Rock River M4 military style rifle loaded with two drum style magazines holding approximately fifty rounds each from the rear of a Jeep SUV at which time the rifle was covered with a towel in an attempt to conceal it. McGrew is accused of then going back to the victim's apartment to confront him, uncovering the rifle.

Deputies responding to the call Wednesday morning spotted McGrew throwing the rifle into a Shalimar dumpster.

The investigation is ongoing.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On July 22, 2015 the defendant Kionte Jamal McGrew went to an address on 100th 8th Avenue apartment 78 to confront the victim Caleb David McCracken about a dispute.

Once at the victim's apartment the defendant loudly threatened him through the door which was heard by several witnesses.

According to the victim and witnesses the defendant challenged the victim to a fight and stated he was going to kill him. The victim refused to come to the door. The victim later stated to your affiant that the reason he did not answer the door was because he knew the defendant was outside, he knew of the defendant's intent, and stated that he was in fear. When the victim would not answer, the defendant then retrieved a Rock River M4 military style rifle which was loaded with 2 drum style magazines containing approximately 50 rounds each from the rear of a Jeep SUV at which time the rifle was covered with a towel in an attempt to conceal it. The defendant went back to the side of the victim's apartment to confront the victim. As the defendant approached the victim's residence he uncovered the rifle and it was visible by witnesses.

The defendant is 17 years of age and went to the victim's house with the intent to commit harm to the victim. The defendant was observed by witnesses and was identified by the victim as Kionte Jamal McGrew.

The SUV was observed by law enforcement and the defendant was observed by law enforcement discarding the rifle in a dumpster.

During a post Miranda interview the defendant admitted to his involvement.

Based on the above information I have probable cause to believe the defendant committed the following offenses. Aggravated assault with a deadly weapon, carrying a concealed firearm, improper exhibition of a dangerous weapon and 18 and under unlawful possession of a firearm to wit: unlawfully carrying a rifle with the intent to do harm to the another and while carrying such firearm attempting to conceal it from view then attempting to destroy or tamper with the evidence when confronted by law enforcement. This is in violation of F.S.S 784.021.1a, 790.01.2, 790.10, 918.13 and 790.22.3 respectively and did occur within Okaloosa County where your affiant is a sworn law enforcement officer.
