# NAVARRE MAN ARRESTED IN CONNECTION WITH OKALOOSA COUNTY SHOOTING, ADDITIONAL CHARGES PENDING



A Navarre man has been arrested in connection with a shooting in West Okaloosa County Tuesday that seriously injured a Fort Walton Beach man.

28-year old Dustin Cooper of 6627 Water Street is charged with aggravated battery with a deadly weapon and possession of a firearm by a convicted felon.

Investigators say Cooper shot 26-year old James Mills following a physical altercation at the home of Mill's ex-girlfriend at 813 Hilltop Road. She told deputies Mills came into the trailer uninvited and attacked Cooper after finding him hiding in a bedroom closet.

As Mills was leaving after the fight, Cooper fired a shot at him, hitting Mills in his motorcycle helmet and lower left portion of his face.

Mills was taken to Sacred Heart Hospital in Pensacola for treatment. Investigators say additional charges are pending in connection with the case.

#### [STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 07-28-15, at approximately 1325 hours, Okaloosa County Deputies responded to 603 Skylark Avenue, Mary Esther, Florida, in reference to a shooting. Upon arrival, they made contact with the victim James Mills, who had been shot with a firearm in his face. Mills stated that he had been shot by Dustin Cooper while in front of another nearby residence, located at 813 Hilltop Road, Florida. Mills provided a more detailed statement to investigators once he arrived at Sacred Heart Medical Center, where he was life flighted to.

Deputies then responded to the scene of the incident, but defendant, Dustin Cooper had already fled the area in a silver in color Toyota RAV 4. Cooper was later located at his residence, 6627 Water Street, Navarre, Florida by Santa Rosa County Deputies. Cooper had obviously been involved in a recent altercation, and after being detained, was transported by EMS to Gulf Breeze Medical Center, where he was treated and released from hospital care. While en route to the hospital, Cooper was read Miranda and invoked his right to legal counsel prior to providing a statement.

Victim, James Mills provided a detailed interview to Investigator Mike Smith while at Sacred Heart Medical Center. Mills stated that he went to Shena Sessum's residence (his ex-girlfriend), which is located at 813 Hilltop Road, Mary Esther, Florida. Mills stated that he went inside the house, and located Cooper hiding inside the bedroom closet. An altercation ensued in which both parties received some physical injuries, however, Mills had put Cooper in a "sleeper hold" which temporarily ended the altercation. While Mills attempted to depart the yard and retrieve his motorcycle, Cooper emerged from the residence. As Mills was departing on his motorcycle, he was approached by Cooper, who was now armed with a pistol. Cooper then fired at Mills, striking the front of his motorcycle helmet. The bullet went through a portion of Mills' helmet. The round entered Mills through an area just above his clin and exited through his left cheek area. According to Mills, Cooper told him prior to shooting, "You're dead Mother-fucker".

Witness, Shena Sessum advised after the altercation occurred inside the residence she and Mills were talking on the front porch when Cooper emerged from inside the residence. Sessum stated another physical altercation occurred between Cooper and Mills, at which time, Mills attempted to retrieve his motorcycle, which was parked a couple houses away. When Mills attempted to depart the area on his motorcycle, Sessum observed Cooper who was armed with a firearm approach Mills. Sessum stated she heard Cooper say "I'm going to kill you", at which time she ran back into the residence to call 9-1-1.

Based upon the above information, I have reason to believe and do believe the defendant, Dustin Chase Cooper, did violate F.S.S. 784.045(1)(a)(2), Aggravated Battery with a deadly weapon. In addition, Cooper is a convicted felon, and as such, violated F.S.S. 790.23(1)(a), Possession of a firearm by a convicted felon in this state. These offenses did occur in Okaloosa County Florida, where your affiant is a sworn law enforcement officer.
