## FWB MAN NABBED WITH THOUSANDS IN STOLEN GOODS



A Niceville man is accused of going on a shopping spree at the Destin Walmart with no intention of paying for his thousands of dollars in merchandise.

The Okaloosa County Sheriff's Office has charged 30-year old Michael Hagan of 1493 Pine Street in Niceville with theft, possession of a controlled substance, resisting an officer without violence, and possession of drug paraphernalia.

Deputies were called to the Destin Walmart around 9 p.m. last night after a loss prevention officer spotted Hagan putting items in a shopping cart and leaving the store without paying. When approached in the parking lot, Hagan ignored a deputy's verbal commands and struggled to avoid being handcuffed. A search of his car turned up more than \$3200.00 in stolen items, including televisions, a computer, and stereo equipment. Deputies also found syringes, a metal spoon, and prescription medications.

Hagan told deputies the drug paraphernalia was to prepare and ingest heroin.

#### [ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On June 15, 2015 the defendant, Michael Hagan did commit the criminal offense of larceny; theft greater than \$300, as outlined in F.S.S. 812.014(2)(c)(1), resisting officer without violence, as outlined in F.S.S. 843.02, possession of a controlled substance without a prescription, as outlined in F.S.S. 893.13(6)(a), and possession of drug paraphernalia, as outlined in F.S.S. 893.147(1).

On the above date, the complainant, a Walmart Loss Prevention Associate, observed the defendant remove anti-theft devices from merchandise, place the merchandise in a shopping cart, and exit Walmart, located in Destin, Florida, without rendering payment for the items. The complainant observed the defendant place the unpaid merchandise into the rear of an unoccupied vehicle and attempt to enter the driver's seat as the uniformed Deputy Sheriff approached. When approached in the parking lot by uniformed Deputy Sheriffs, the defendant ignored verbal commands to comply with lawful orders. The defendant tensed his body and refused to allow his hands to be handcuffed by a Deputy Sheriff. He forced his hands and arms towards his chest struggling against the Deputy Sheriff's attempts to place his hands towards his back. I un-holstered my TASER at the defendant and removed any safety feature while shouting commands to stop resisting. The defendant was eventually detained in handcuffs after I "sparked" my TASER and threatened to deploy if he continued resisting the Deputy Sheriff and complainant who assisted. The unpaid merchandise was visible through the defendant's vehicle windows. The complainant identified the items as stolen. The defendant admitted stolen merchandise was located in the vehicle. A search of the defendant's vehicle revealed numerous items of stolen merchandise from Walmart as well as several syringes, a metal spoon and a clear plastic bag with cloth filters. In a post-Miranda interview, the defendant admitted the above items are used to prepare and inject heroin. A tablet of Alprazolam 2mg also was discovered in the vehicle. The controlled medication is available only by prescription. The defendant was unable to provide proof of current prescription for the tablet.

The total value of the merchandise recovered from the defendant's vehicle was \$3,241.77. Walmart video surveillance confirmed the defendant selected the unpaid merchandise, placed it into a shopping cart, passed all points of payment, and exited the store.

Based on the above facts, I believe defendant, Michael Hagan did knowingly and willfully commit the criminal offense of of larceny; theft greater than \$300, as outlined in F.S.S. 812.014(2)(c)(1), resisting officer without violence, as outlined in F.S.S. 843.02, possession of a controlled substance without a prescription, as outlined in F.S.S. 893.13(6)(a),
