TWO CHARGED FOLLOWING NARCOTICS SEARCH WARRANT

The Okaloosa County Sheriff's Office Narcotics Unit executed a warrant today at a home in Shalimar, arresting two women on drug charges.

45-year old Jeannie L. Roberts of 27-A 11th Street in Shalimar and 47-year old Becky Trimm of Arlington, Texas were arrested after investigators found numerous small plastic jewelry bags containing crystal methamphetamine at Roberts' home.

Roberts is charged with possession of a controlled substance with intent to distribute (methamphetamine), possession of marijuana under 20 grams and possession of drug paraphernalia. Trimm is charged with possession of controlled substance (methamphetamine) and possession of drug paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On June 18, 2015, a lawful search warrant was executed at 27A 11th Street, Shalimar, Florida.

During the execution of the search warrant, the DEFENDANT, Jeannie Roberts, and the CO-DEFENDANT, Becky Trimm, were present at the residence.

During a search of the residence, numerous items indicative of drug distribution were located within the residence. Those

items included, but were not limited to, the following:

- Plastic jewelers bag containing approximately five (5) grams of crystal methamphetamine located in the master bathroom closet
- One (1) glass methamphetamine smoking pipe and clear jewelers bags located in the master bathroom closet
- Plastic jewelers bag containing less than one (1) gram of marijuana located underneath the master bathroom sink
- Plastic jewelers bag containing approximately one (1) gram of crystal methamphetamine located in multi-colored purse with the DEFENDANT's identification
- Plastic jewelers bag containing approximately two (2) gram of crystal methamphetamine located in multi-colored purse with the DEFENDANT's identification
- Plastic jewelers bag containing approximately one (1) gram of crystal methamphetamine located in black bag in the hallway by the kitchen
- Plastic jewelers bag containing approximately one-quarter (1/4) gram of crystal methamphetamine located in black bag in the hallway by the kitchen
- Clear vial containing approximately one-quarter (1/4) gram of crystal methamphetamine located in black bag in the hallway by the kitchen

Post Miranda, the DEFENDANT stated she purchased a majority of the above mentioned crystal methamphetamine from the CO-DEFENDANT for \$380.00 and that the CO-DEFENDANT brought the crystal methamphetamine to her from Texas. The DEFENDANT stated she sells the crystal methamphetamine for approximately \$100.00 per gram. The DEFENDANT further admitted to smoking methamphetamine and utilizing the above mentioned methamphetamine pipe to do so.

The above mentioned evidence was confirmed to be such through their physical appearance and/or a presumptive field test result for the presence of methamphetamine.

Based on the DEFENDANT's statements, combined with the manner/method the controlled substances were packaged in, your AFFLIANT has probable cause to believe and your AFFLIANT does believe, Jeannie Roberts, knowingly violated Florida State Statutes 893.13.1a2; Possession of crystal methamphetamine with intent to distribute, 893.13.6b; Possession of marijuana less than twenty grams, and 893.147.1; Possession of drug paraphernalia.

This incident did occur within Okaloosa County, Florida, where your AFFLIANT is a sworn Law Enforcement Officer.

- Blue plastic jewelers bag containing approximately one (1) gram of crystal methamphetamine
- One (1) glass methamphetamine smoking pipe

Post Miranda, the DEFENDANT stated she sells crystal methamphetamine to the CO-DEFENDANT for \$380.00 and that the DEFENDANT brought the crystal methamphetamine to her from Texas. The DEFENDANT identified the above mentioned glasses case as belonging to her and to possession of the crystal methamphetamine that was contained therein. The DEFENDANT further admitted to smoking methamphetamine and utilizing the above mentioned methamphetamine
