CRESTVIEW MAN CHARGED WITH PUNCHING, KICKING AND STOMPING FORMER GIRLFRIEND



A Crestview man is charged with attacking his former girlfriend at her home, then fleeing through the neighborhood. Deputies eventually found 29-year old Timothy Jermaine Lowe hiding in bushes after a man called the Okaloosa County Sheriff's Office to report someone matching the suspect's description walking through his field.

Lowe is now charged with battery and felony domestic violence battery by strangulation.

The 21-year old victim says she had driven to Lowe's house on Oakdale Avenue Thursday to return money to him when he pushed her into her car and drove to her home on Poverty Creek Road. Once there she says Lowe struck her in the face with a closed fist, causing her to fall down. She says Lowe then kicked and stomped her around her head, face, and neck, applying enough pressure on her throat to stop her ability to breathe.

The victim's mother called the OCSO after arriving at the house and finding her daughter badly beaten. Deputies say the victim's mother demanded that Lowe leave, and eventually chased him out of the home while holding a baseball bat.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Victim, Danielle Dance and defendant, Timothy Lowe, were in the past involved in a domestic relationship, in which they were in a relationship and lived together as a family. A physical disturbance occurred, between the two with injuries. Probable Cause, exists for arrest and the defendant was taken into custody after an intensive search was conducted.

The following, is statements along with physical evidence which is supported by Chapter 784, FSS.

As per the victim's statement, during the morning hours of 6/25/2015, Both victim, defendant, and a male subject only identified as Keith, arrived at the Split Oak Saloon, located at 892 West James Lee, Blvd., Crestview, Florida. The three all arrived together in the same vehicle. When the three departed the victim, took the defendant, home before taking the mutual friend home. She returned to the defendant's residence shortly afterwards to return money to him she had in her

possession. Upon arrival at 397 Oakdale Avenue, the defendant, met the victim in the front yard, accusing her of infidelity. He placed his fingers in her mouth and pushed her into the passenger seat. The defendant, then drove them to the victim's residence located at 3960 Poverty Creek Road, Crestview, Florida. While there the defendant, struck the victim about the face with a closed fist. The victim lost her footing and fell onto her back, at which time the defendant, kicked and stomped her about the head, face and neck. The victim advised the defendant kept his foot on her throat applying enough pressure to stop her ability to breathe. The victim also complained of pain to the right knee where the defendant, also kick and stomped her about the right leg.

As per, witness, Nancy Fortune, mother of the victim, she received a call from the victim, for help getting dressed. Upon her arrival she observed the victim in the bedroom floor with swelling to the face. She also observed the defendant, standing nearby in the bathroom. After a short verbal confirmation, and repeated demands for the defendant to leave the residence she successfully removed him while holding a baseball bat.

Contact was made with the defendant, at the Okaloosa County Jail, at his request. Upon my arrival he asked what his charges was. He confirmed that he went with the victim to the Split Oak Saloon, however, when asked what occurred at the victim's residence, he refused to answer questions.

As per Doctor Christopher L. Singley, MD. with North Okaloosa Medical Center, the victim, sustained a concussion. Diagnosis: Face-Scalp-Neck Contusion; Head Injury; Assault; Concussion without LOC; Abrasion of multiple sites w/o infection.

Based on the above information and physical evidence, I have reason to believe the defendant, committed the offense of Battery in violation of FSS 784.03(1a1) and DOMV Battery by strangulation, in violation of FSS 784.041
