## **OCSO DEPUTY SPOTS SUSPECT IN RASH OF ROBBERIES**



A Fort Walton Beach man is charged with three separate robberies after an Okaloosa County Sheriff's Deputy noticed he resembled the man shown in a surveillance photo from one of the crimes.

43-year old Javonne Terrell Murphy of 908 Squirrel Court in Fort Walton Beach is charged with grabbing a \$100 bill from an employee at the Waffle House at 460 Racetrack Road shortly before midnight Monday. He's also accused of robbing the Tom Thumb at 1096 North Beal Parkway approximately two hours later, and of attempting a hold-up at the Thumbs Up Food Store at 443 Green Acres Road five hours after that.

A Deputy made contact with Murphy after spotting him in the area of Beverly Street and Union Street Tuesday afternoon. He noticed Murphy resembled the person in a crime scene surveillance photo that had been distributed to deputies.

Murphy told investigators he is addicted to crack cocaine and had stolen the money to get drugs.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On June 29, 2015, at approximately 2323 hours, the Defendant, Javonne Terrell Murphy, entered the Waffle House, located at 460 Northwest Racetrack Road, Fort Walton Beach, Florida. Murphy requested a cup of water and sat at the counter top located inside of the restaurant for a brief period of time.

At approximately 2327 hours, a customer was attempting to pay an employee for a meal using a \$100 bill. Murphy moved towards the area of the transaction. Once the employee had the money in her hand, Murphy reached over the counter, snatched the money from the employee, and ran out the business, fleeing through the adjacent parking lot on foot.

This incident was captured with the establishment's surveillance system. In the video, Murphy can be seen wearing a green in color rubber bracelet on his left wrist.

On June 30, 2015, Murphy also robbed the Tom Thumb, located at 1096 North Beal Parkway, approximately two hours after this incident. Murphy also attempted to rob the Thumbs Up Food Store, located at 443 Green Acres Road, approximately five hours after this incident. These locations are within close proximity to the aforementioned establishment. These locations also had surveillance video and Murphy was identified as the same subject from this

particular robbery.

On June 30, 2015, Deputy Adam Fitchett observed Murphy in the area of Beverly Street and Union Street. He believed Murphy resembled a photograph that had been distributed in order to identify the perpetrator of the above incidents. Murphy was ultimately detained and transported to the Criminal Investigations Division in order to be interviewed.

Prior to Murphy's arrival at the Criminal Investigations Division, I compared one of his mug shots to the surveillance video from the Thumbs Up Food Store. I was able to positively identify him as the person depicted in the surveillance video. The footage of the robbery in this incident was also able to be reviewed and I subsequently identified him as the individual depicted.

Upon making contact with Murphy, I noted he was wearing the same green in color bracelet on his left wrist that he was observed wearing in the surveillance videos.

Post Miranda, Murphy confessed to snatching the \$100 from the waitress and running away from the scene. Murphy claimed he has an addiction to "crack" cocaine and had stolen the money to obtain narcotics.

This is in violation of F.S.S. 812.131, Robbery by Sudden Snatching, and did occur in Okaloosa County, Florida.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On June 30, 2015, at approximately 0148 hours, the Defendant, Javonne Terrell Murphy, entered the Tom Thumb, located at 1096 North Beal Parkway, Fort Walton Beach, Florida. Once inside of the store, Murphy appeared to be composing a text message on his cellular phone while he waited for another customer to depart.

At approximately 0151 hours, Murphy approached the clerk behind the counter and showed her his cellular phone. According to the clerk, the phone displayed a message, which stated, "relevent to give me all your money and you will be okay." Smith subsequently empty the cash register of the \$192.00 it contained and surrendered the money to Murphy. Murphy then departed the store.

This incident was captured with the establishment's surveillance system. In the video, Murphy can be seen conducting counter surveillance, consisting of circling the store, prior to entering. Murphy can also be seen wearing a green in color rubber bracelet on his left wrist.

On June 29, 2015, Murphy also robbed the Waffle House, located at 460 Northwest Racetrack Road, approximately two hours prior this incident. Murphy also attempted to rob the Thumbs Up Food Store, located at 443 Green Acres Road, less than three hours after this incident. These locations are within close proximity to the

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On June 30, 2015, at approximately 0430 hours, the Defendant, Javonne Terrell Murphy, entered the Thumbs Up Food Store, located at 443 Green Acres Road, Fort Walton Beach, Florida. Once inside of the store, Murphy approached the clerk and showed him his cellular phone. On the phone, a message was written, which stated, "Your being robbed, don't do anything and you won't get hurt." Murphy then walked behind the counter and told the clerk to get back. Murphy then tried to open the register but was unsuccessful. He then told the clerk to open the register and the clerk told him he didn't have the password to do so. After making unsuccessful attempts to get into the register and the safe, Murphy gave up and departed the establishment.

The clerk remembered observing Murphy enter the store at 0130 hours. During that occasion, Murphy approached the clerk, who had asked if he could help. Murphy told the clerk to "never mind" and then left the store.

This incident was captured with the establishment's surveillance system. In the video, Murphy can be seen wearing a green in color rubber bracelet on his left wrist.

On June 29, 2015, Murphy also robbed the Waffle House, located at 460 Northwest Racetrack Road, approximately five hours prior this incident. Murphy also robbed the Tom Thumb, located at 1096 North Beal Parkway,

less than three hours prior this incident. These locations are within close proximity to the aforementioned establishment. These locations also had surveillance video and Murphy was identified as the same subject from this particular attempted robbery.

On June 30, 2015, Deputy Adam Fitchett observed Murphy in the area of Beverly Street and Union Street. He believed Murphy resembled a photograph that had been distributed in order to identify the perpetrator of the above incidents. Murphy was ultimately detained and transported to the Criminal Investigations Division in order to be interviewed.

Prior to Murphy's arrival at the Criminal Investigations Division, I compared one of his mug shots to the surveillance video from this incident. I was able to positively identify him as the person depicted in the surveillance video. The footage of the robbery in this incident was also able to be reviewed and I subsequently identified him as the individual depicted.

Upon making contact with Murphy, I noted he was wearing the same green in color bracelet on his left wrist that he was observed wearing in the surveillance video.

Post Miranda, Murphy stated, "I did this shit." He confessed to going into the establishment, ordering the clerk to open the register and give him money, and attempting to open the register himself. Murphy admitted he was unable to obtain any money and subsequently left the premises. Murphy claimed he has an addiction to "crack" cocaine and had stolen the money to obtain narcotics.

This is in violation of F.S.S. 812.13(2c), Attempted Robbery, and did occur in Okaloosa County, Florida.
