OCSO NARCOTICS UNIT INVESTIGATION INTO DRUG DISTRIBUTION NETWORK NETS ARREST



During the month of March 2015 members of the Okaloosa County Sheriff's Office Narcotics Unit initiated an investigation into a drug distribution network allegedly operated by 29-year old Kim Denord Gibson of Miami. Information had been developed that Gibson was traveling to Okaloosa County from Miami in order to distribute large amounts of pharmaceutical medications.

On June 26, 2015, members of the Okaloosa County Sheriff's Office Narcotics Unit conducted a controlled purchase of approximately twenty (20) grams of suspected Hydromorphone tablets from Gibson. Upon completion of the controlled purchase, he was immediately taken into custody by law enforcement officers without incident. During a search incident to arrest an additional approximate five (5) grams of suspected Hydromorphone was seized.

Gibson is charged with Trafficking in Opium or Derivative (Approximately 25 Grams); and Unlawful use of a two-way communications device.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 06-26-2015 your Affiant, following a set of established procedures, utilized a confidential source, hereinafter referred to as the CS, to arrange and conduct a controlled purchase of suspected Hydromorphone tablets from Kim Denord GIBSON (defendant). This controlled purchase took place at 4301 Legendary Drive, Destin, Okaloosa County, Florida.

GIBSON and the CS utilized telephonic communication to arrange the controlled purchase. GIBSON and the CS made contact and the drug transaction took place. Upon completion of the controlled purchase, law enforcement agents arrived and took GIBSON into custody. It should be noted that GIBSON sold approximately 20 grams of suspected Hydromorphone to the CS in exchange for \$3,000.00 in documented police drug buy money.

Search incident to arrest, GIBSON was found to be in possession of an additional approximate 5 grams of suspected Hydromorphone, the documented police drug buy money, and the cellular device utilized to arrange the drug transaction.

The suspected Hydromorphone purchased from GIBSON, during the controlled operation, were inscribed "54 425." Your Affiant queried this number, via www.Drugs.com pill identifier, and confirmed these pills as being

Hydromorphone Hydrochloride 8mg.

The suspected Hydromorphone seized from GIBSON's person, search incident to arrest, were inscribed "M 8." Your Affiant queried this number, via www.Drugs.com pill identifier, and confirmed these pills as being Hydromorphone Hydrochloride 8mg.

The combined weight of the suspected Hydromorphone was approximately 25 grams, making this a trafficking offense.

Based on the above, your Affiant has probable cause to believe that Kim Denord GIBSON did violate Florida State Statutes 893.135.1c1b: Trafficking in Opium or Derivative (Approximately 25 Grams); and 934.215: Unlawful use of a two-way communications device.
