UNDERCOVER NARCOTICS INVESTIGATION **LEADS TO MULTIPLE ARRESTS**

A nearly two month long investigation conducted by the Okaloosa County Sheriff's Office Narcotics Unit led to a warrant round-up titled, Operation "Still Watching". This investigation began after the OCSO received numerous citizen complaints about the street side sale of illegal narcotics occurring in their respective neighborhoods to include Sylvania Heights (near Ft. Walton Beach), Carson Drive (City of Ft. Walton Beach) and Martin Luther King Jr. Blvd in Crestview. The operation also included the arrests of other narcotics violators and violent offenders in Okaloosa County, as well as a Baker man charged with 25 counts of possession of child pornography. This operation was conducted with the assistance of the U.S. Marshals Service and the Air Force Office of Special Investigations (OSI). As a result, the following suspects were arrested:

Michael T. Goodwin, 45, Pensacola – Possession of a controlled substance, Possession of marijuana under 20 grams, Possession of drug paraphernalia

Darian K. Caldwell, 22, 530 N. Eglin Pkwy, Fort Walton Beach – Possession of a controlled substance, Possession of drug paraphernalia

Markell V. Bush, 21, 502 NW Earl Street, Fort Walton Beach - Possession of cocaine with intent to sell, Sale of cocaine

Jeffrey Rodgers, 24, 220 NW Poplar Avenue, Fort Walton Beach – Sale of cocaine
