### SUSPICIOUS VEHICLE CALL LEADS TO STOLEN CAR CHARGES

Two Fort Walton Beach teenagers are charged with car theft after they were found sitting in the stolen vehicle at a vacant lot yesterday evening.

Okaloosa County Sheriff's Office deputies responding to a call of a suspicious car around 9 p.m. found 18-year old Antonio Prather of 117 Bradford Street and 15-year old Jadden Edwards of 523 Union Street inside a white Mercedes backed into a vacant lot on Weeks Road. Two juvenile passengers were in the back seat.

Deputies say when they approached the car; Edwards had a pink mini taser in his lap in plain view. While searching Edwards, deputies found a single grey car key in his front pocket and another key with an orange tag in his left pocket. Additional keys were also found in the front glove box and console.

A check of the car revealed it had been reported stolen out of Niceville. Prather is charged with vehicle theft and providing false information while detained. Edwards is charged with vehicle theft and open carry of a weapon. The juvenile passengers were released to their parents.

The investigation is continuing.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On March 23, 2015 a white in color 2005 Mercedes C230, bearing Florida tag 223PXZ was stolen out of Niceville, Florida (NPD15OFF000337).

The vehicle was located in a vacant lot across from 920 Weeks Road, Fort Walton Beach, Florida. The vehicle was occupied by the defendant Jadden Lamar Edwards and codefendant. Edwards was sitting in the front passenger seat of the vehicle. On Edwards lap, in plain view, was a pink in color Lil Demon, Model PHX800 Mini Stun Gun. Edwards stated he had found the stun gun in the glove box and had been carrying it on his lap. Edwards stated he and the co defendant had rented the vehicle for \$40 from two unknown males. Edwards stated he and the co defendant had been driving the vehicle around all day.

Two witnesses stated Edwards came and picked them up in the white in color Mercedes. Both witnesses stated Edwards drove them around in the car until they parked on Weeks Road.

The vehicle was located in a vacant lot across from 920 Weeks Road, Fort Walton Beach, Florida. The vehicle was occupied by the defendant Antonio Lamar Prather and co defendant who was in the front passenger seat. Prather was sitting in the driver's seat and the keys were in the ignition. Prather had physical control of the vehicle.

After Prather was detained and informed of his Miranda warning, he stated his name was Tyrone L Prather with a date of birth of October 9, 1995. Prather was asked several times if this was his correct name, he advised itwas. Prather stated he had never seen the vehicle until he walked over from his residence and got in to visit with friends. Prather also stated he had never driven the vehicle. After being transported to the Okaloosa County Booking Facility, Prather then stated his name was Antonio Lamar Prather with a date of birth of 12/12/1996.

Codefendant stated he and Prather had been driving the vehicle all day long. Codefendant stated they had rented the vehicle for \$40 from two unknown males.

An NCIC/FCIC check of the Mercedes run by OCSO Communications revealed that the Mercedes was in fact listed as stolen out of Niceville Police Department.

Based on my investigation which included interviews with the defendants and gathering of physical evidence, I believe Antonio Lamar Prather violated F.S.S. 812.014(2C6) Vehicle Theft and F.S.S. 901.36.1 Providing False Information to LEO While Lawfully Detained.
