FWB MAN FACING SEXUAL BATTERY ON A CHILD CHARGES



The Okaloosa County Sheriff's Office has arrested a Fort Walton Beach man on charges he sexually molested a child over a period of approximately six years.

34-year old Pedro Lopez-Emeterio is charged with three counts of sexual battery on a victim over the age of 12, three counts of fondling a child less than sixteen, and one count of lewd and lascivious molestation on a victim under age twelve.

The OCSO arrested Lopez-Emeterio March 2nd at his home on Vincent Lane.

Investigators say Lopez admitted to the sexual contact that began when the victim was eight years old.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On February 28, 2015, I responded to [REDACTED] Fort Walton Beach, in reference to a disclosure of sexual battery by a child during a joint child abuse investigation. During a forensic interview at the Children's Advocacy Center, [REDACTED] said [REDACTED] Pedro Lopez, "touched me in my private parts" and he "made me touch his private parts". [REDACTED] said it has happened on more than one occasion with the first time being when she was eight years old, [REDACTED] touched her "boobs," her neck, and her butt under her clothes. On the most recent

occasion less than a year ago, [redacted] standing by the door, he came over to her bed, touched her on "her parts", she pointed to her breasts and clarified that he touched her "boobs". [redacted] said he also touched her neck and then "down here", pointing to her groin, she said, "vagina".

[redacted] said other times [redacted] hugged her, touched her neck, breasts, legs, butt, on top of and under her clothing. [redacted] said on more than one occasion [redacted] put his fingers inside of her vagina. [redacted] said he also made her manually stimulate his penis with her hands. [redacted] said he wanted her to "touch his penis." He picked up her hand and directed it to his penis, and made her move her hand up and down.

On March 2, 2015, I made contact with Pedro Lopez-Emeterio at Okaloosa County Sheriff's Office Criminal Investigations in a non-custodial interview. Pedro's first language is Spanish, however, he communicated in English quite fluently. Deputy Rojas assisted during the interview in providing Pedro his rights in Spanish to ensure comprehension. Post Miranda, in a sworn written and verbal statement, Pedro admitted that he had inappropriate sexual contact with [redacted] beginning when she was about 7 or 8 years old, until sometime last year when she was approximately 14 years old.

Pedro said the first time he touched [redacted] inappropriately was on her butt, when she was about 7 or 8 years old. He said he wasn't sure where [redacted] lived at the time, either in an apartment or another mobile home [redacted] told her mother's friend, and then her mother; Pedro said he denied it at the time. During the interview, Pedro admitted that when he touched [redacted] inappropriately on her buttocks it was for sexual pleasure. He said she was "more scared" that time than on later occasions. Pedro said he was unable to resist her. Based on my investigation I have probable cause to believe and do believe Pedro Lopez-Emeterio committed Lewd or Lascivious Molestation, in violation of F.S.S. 800.04.5B, when he intentionally touched [redacted] on her buttocks when she was less than twelve years old.

Pedro said about a year and a half ago, he and [redacted] were alone together in his vehicle after dropping off his sister. Pedro said he was touching and rubbing [redacted] shoulders as he drove, and she moved his hand towards her breast. Pedro said he rubbed and touched her breasts while they drove home, but he didn't do anything else to her on that occasion. Pedro said he did get aroused, but he controlled himself after [redacted] went home. Pedro said on at least 2 or 3 occasions, during the last year and a half, he touched [redacted] on her breasts. Pedro said sometimes he went [redacted] and touched her breasts. Pedro said [redacted] when he touched her. Based on my investigation, I have probable cause to believe, and do believe, Pedro Lopez-Emeterio committed at least two counts of Lewd or Lascivious Molestation, in violation of F.S.S. 800.04.5A, when he intentionally touched [redacted] on her breasts when she was less than 16 years old.

Pedro admitted that on at least one occasion [redacted] he guided her hand towards his penis and she moved her hand up and down on his penis. Pedro said at some point [redacted] pushed him away and he left her room. Based on my investigation, I have probable cause to believe, and do believe, Pedro Lopez-Emeterio committed another violation of F.S.S. 800.04.5A, Lewd or Lascivious Molestation, when he forced or enticed a person under 16 years of age, [redacted] to touch his genitals.

Pedro said on about 3 or 4 occasions during the last year and a half, he put his finger(s) into [redacted] vagina. Pedro said after he put his fingers in her vagina he would leave [redacted] go into the bathroom, and masturbate. Based on my investigation, I have probable cause to believe, and do believe, Pedro Lopez-Emeterio, a person who is [redacted] to a person less than 18 years of age, [redacted] committed at least three counts of Sexual Battery when he penetrated her vagina with his finger(s), in violation of F.S.S. 794.011.8B.

These offenses did occur in Okaloosa County where I am a sworn law enforcement officer.
