FWB MAN FACING SEXUAL BATTERY ON A CHILD CHARGES



The Okaloosa County Sheriff's Office has arrested a Fort Walton Beach man on charges he sexually molested a child over a period of approximately six years.

34-year old Pedro Lopez-Emeterio is charged with three counts of sexual battery on a victim over the age of 12, three counts of fondling a

child less than sixteen, and one count of lewd and lascivious molestation on a victim under age twelve.

The OCSO arrested Lopez-Emeterio March 2nd at his home on Vincent Lane.

Investigators say Lopez admitted to the sexual contact that began when the victim was eight years old.
