BAKER MAN CHARGED WITH MOLESTING CHILD



A Baker man has been charged with sexually molesting a young girl in December of last year.

The Okaloosa County Sheriff's Office today arrested 27-year old Joshua Eli Retzloff of 1699 Vinson Ray Road for lewd and lascivious battery on a child under the age of twelve.

Investigators say in interviews with law enforcement and a Child Protection Team, the child's account of the sexual abuse never varied.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 12/10/14 a complaint was received by the Okaloosa County Sheriff's Office that a [REDACTED] Joshua Eli Retzloff, who is 27 years of age had sexual contact with [REDACTED] who is 9 years of age. Your Affiant responded to the scene and spoke with the grandparents of [REDACTED] who advised [REDACTED] was upset about something and told [REDACTED] who she later identified as Joshua Eli Retzloff didn't love her any more. She then went further and stated they had done private things together. [REDACTED] then told her grandparents that Retzloff rubbed her pubic area and then pulled out his penis and asked her to rub it because it felt good to him. [REDACTED] stated that when she did this a milky substance came out of the end. She further stated that Retzloff had kissed her on the mouth sliding his tongue into her mouth.

On 12/11/15 [REDACTED] was interviewed by Samantha Collazo of the Child Protection Team. During this meeting [REDACTED] stated that on 12/09/14 [REDACTED] had to go to the store to pick up items and had Joshua Retzloff, [REDACTED] [REDACTED] e; [REDACTED] While Retzloff was with her, he placed his tongue into her mouth as they kissed. She further stated that Retzloff had [REDACTED] rub his "boy stuff" later identified as his penis and that Retzloff licked her girl stuff, identified as her vagina. During the examination, [REDACTED] drew multiple photographs which were graphic in nature, one depicting her rubbing his penis and there was no doubt the penis was ejaculating from the photo. She described this as something that looked like mayonnaise came out of the end. [REDACTED] stated this was the only time this had occurred. [REDACTED] stated this occurred in [REDACTED] and at the time they were on the side of and in [REDACTED] She advised they began kissing and then Retzloff began putting his tongue into her mouth. She stated that he then put his finger in his mouth and then began to rub her vaginal area with his finger. He then had her rub his penis and he then began to kiss her vaginal area. [REDACTED] confirmed that Retzloff took off her clothing

and all contact was without her clothing.

On 12/09/14 this Investigator did a non-custodial audio interview with Joshua Eli Retzloff at the North District Office. We spoke about the incident with [REDACTED] and he stated that he felt she was truthful as a norm. I asked him if he had ever kissed her and [REDACTED] stated that he did. He went on to say he kissed her because he felt she was in need of attention. I advised him [REDACTED] stated he had rubbed and touched her in personal places. He hesitated then said no. I then told him [REDACTED] was very explicit in her descriptions to the point of describing masturbation and ejaculation. He would sigh and tear during the allegations. When asked about the kissing with his tongue he stated he was not sure if it had happened or not. After being advised of the allegations he invoked his right to counsel

The victim was interviewed by law enforcement, as well as by Child Protection Team personnel and never varied from her account in any way. Based on the fact the victim is 9 years of age and the defendant Joshua Eli Retzloff was 27, [REDACTED] and had union between his tongue and the vagina of the victim, and also had her masturbate his penis until he ejaculated: This Investigator has reason to believe and does believe that Joshua Eli Retzloff did commit the crime of Lewd and Lascivious Battery on a child under the age of 12. This offense did occur in Okaloosa County, Florida.
