INTOXICATED MAN ARRESTED AFTER DISRUPTING CHURCH SERVICE, THREATENING DEPUTY



A Holt man faces charges after entering a church in Milligan and yelling profanities before attempting to walk down State Road 4. An OCSO Deputy attending the church service at First Assembly of God April 29th was concerned for the safety of 44-year old Michael Holman, who smelled of alcohol and was having trouble keeping his balance as he walked towards the road. When he attempted contact with him however, Holman became aggressive and would not remove his hands from his pockets. He then threatened to take the deputy's firearm and kill him and lunged towards the officer.

Holman was taken into custody and is charged with disorderly intoxication and threatening a public servant.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE 1

On Wednesday, April 29, 2015, I was dispatched to an intoxicated person at the First Assembly of God Church Milligan, located at 5408 State Rd 4, Baker, Florida. While en route I was advised by dispatch that an off-duty deputy, identified as D/S Drane, had restrained the defendant, identified as Michael Holman.

The defendant had walked into the church and had become belligerent and using profanities and was asked to leave, which the defendant complied. A strong odor of an alcoholic beverage was emitting from his person and he was having serious balance issues and was walking towards State Rd 4, deputy Drane concerned for the defendant's safety again made contact with the defendant. The defendant became aggressive and would not listen to the commands given by deputy Drane, who had identified himself to the defendant, utilizing his badge. The defendant had to be repeatedly instructed to remove his hands from his pockets and deputy Drane had become concerned to the point of placing his hand on his weapon, though it was never fully removed from the holster. After the defendant realized deputy Drane was armed he informed deputy Drane that he would take his firearm and kill him with it and lunged in an aggressive manner toward deputy Drane with his hands clenched into fists and was taken to the ground.

Based on my investigation and witness statements I can and do believe the defendant violated F.S.S. 838.021.3b Corrupt by threat public servant, and F.S.S. 856.011 (1) Disorderly Intoxication. These offenses were committed in Okaloosa
