SUBWAY BURGLARY SUSPECTS IN CUSTODY



Two people are in custody in connection with the May 17<sup>th</sup> burglary of a Mary Esther Subway that was caught on surveillance video.

52-year old Barry Banfield and 43-year old Laura Lee Price, both of 1120 Lowery Drive in Fort Walton Beach, were taken into custody Thursday evening and are now charged with burglary, theft, and criminal mischief.

Investigators say the pair smashed the glass door of the Subway at 421 Mary Esther Boulevard in the early morning hours and stole a safe containing nearly \$3000.

Investigators developed Banfield and Price as suspects, and discovered Price is a former employee of the restaurant.

When contact was made with Price, she admitted to her part in the crime.

### [STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 05-17-15, Okaloosa County Deputies responded to the Subway Restaurant located at 421 Mary Esther Cutoff, Mary Esther, Florida, in reference to a burglary which already occurred. Upon arrival, Deputy Johnson made contact with the reporting person, Clayton Magouirk, and observed that the glass to the front door had been broken out.

Per affidavit of complaint from store manger Regina Huffman, the suspects had entered the store and stole the safe which contained \$2,776.44. On 5-21-15, Huffman verbally stated that the estimated damage to the property was \$900. A review of the store surveillance video showed someone breaking the glass out of the front door, followed by a white female and white male making entry. The female appeared to be familiar with the store, as she ran to the back of the store and then return to the register to check for money. She then removed the safe from under the counter, dragging it to the portion of the restaurant where patrons would eat. The male individual then picked up the safe and the two departed the same area where they entered.

Video footage from the rear parking lot of Cash America (a nearby business) was obtained. This video showed a conversion van with wide striping on the sides enter the rear parking lot at approximately 0350 hours on 05-17-15, and exit approximately 10 minutes later.

Barry Banfield and Laura Price, who reside at 1120 Lowrey Drive, Fort Walton Beach, Florida, were developed as suspects. At that time, it was discovered that Price is a former employee of the Subway Resturant. During a check of their residence on 05-20-15, a green in color Dodge conversion van with large striping on the sides was located. This van, bearing Florida Registration Tag L356ZF was registered to Martin Price (husband of Laura Price) of that address.

On 05-21-15, contact was made with co-defendant Laura Price. Post Miranda, Price admitted to her part in the burglary. She stated that she has been off her medications, in addition to using illegal drugs and alcohol. She further admitted that her co-defendant, Barry Banfield was with her at the time of the burglary. Price was then arrested.

In addition to interviewing Laura Price, I spoke to her husband, Martin Price. Martin Price viewed the stores video footage that had been posted to the Sheriff's Office Facebook Page. Price confirmed that the male in the video was Banfield, and stated that the female looked like his wife, although he could not see her face.

Approximately 2 hours later, defendant Barry Banfield returned to the residence from his place of employment. Post Miranda, Banfield elected not to answer any questions without an attorney present.

Based upon the above information, I have reason to believe and do believe that the defendant, Barry T. Banfield, violated F.S.S. 810.02(4)(a), Burglary of Structure, Unarmed; F.S.S. 812.014(2)(c)(1), Theft valued at \$300 or more, but less than \$5,000; and F.S.S. 806.13(1)(b)(2), Criminal Mischief, damage to property greater than \$200 but less than \$1,000. These offenses did occur in Okaloosa County, Florida, where your affiant is a sworn law enforcement officer.
