MAN CHARGED WITH ATTEMPTED MURDER IN MACHETE ATTACK

The Okaloosa County Sheriff's Office has charged a Fort Walton Beach man with attempted murder in connection with a machete attack Sunday outside a business on Racetrack Road.

Deputies were called to Loranna's Cantina at 402 Racetrack Road around 3:30 Sunday in connection with an aggravated battery. They say 38-year old Miguel Guzman of 812 Denton Boulevard hit 52-year old Marco Barnica-Pena in the back of the head with a machete, causing a four inch laceration which required six staples to close. The incident was captures on a security video from the parking lot of the business. It also shows Guzman's girlfriend, 50-year old Norma Zapata, picking up the machete from the ground, hiding it behind her, and then passing it to another woman who puts it in Guzman and Zapata's trunk of their car.

Zapata is charged with principal to attempted second degree murder.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 05/03/2015 the defendant, Miguel Guzman, did strike the victim, Marco A. Barnica-Pena in the back of the head with a machete causing a four inch laceration which needed six staples to close. This incident occurred in the parking lot of Loranna's Cantina located at 402 Racetrack Rd. in unincorporated Okaloosa County after an altercation inside the business. The defendant knew, or should of known, that the imminently dangerous act of stiking the victim in the head with a machete could cause death.

The victim provided a sworn affidavit of complaint detailing the events of the incident. The victim and witness, Bruno Mendez, did participate in a show up at the suspect's residence where a positive identification was made. The incident was also captured on security video from the parking lot of the business and corroborates the victim's and witness' account of the events.

Based on the above information the affiant has reason to believe, and does believe, that the defendant Miguel Guzman, did violate F.S.S. 782.04(2): Attempted Second Degree Murder. This is contrary to the decency of the people of Okaloosa County, state of Florida where your affiant is a sworn law enforcement officer.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 05/03/2015 the co-defendant, Miguel Guzman, did strike the victim, Marco A. Barnica-Pena in the back of the head with a machete causing a four inch laceration which needed six staples to close. This incident occurred in the parking lot of Loranna's Cantina located at 402 Racetrack Rd. in unincorporated Okaloosa County after an altercation inside the business. The co-defendant knew, or should of known, that the imminently dangerous act of striking the victim in the head with a machete could cause death.

The victim provided a sworn affidavit of complaint detailing the events of the incident. The incident was also captured on security video from the parking lot of the business and corroborates the victim's account of the events. Depicted on the video is the defendant, Norma Zapata, observing the co-defendant engaged in the act of striking the victim with the machete in the head. The defendant is then seen picking up what is later to be determined to be the machete off the ground, concealing it behind her leg and back and then passing it to another female who puts the machete in the trunk of the defendant and co-defendant fled from the scene together and were later contacted at their residence. During a consensual search of the vehicle the machete was recovered from the trunk.

Do to the above information the affiant has reason to believe, and does believe, that the defendant, Norma Zapata, is principle to f.s.s. 782.04 (2): Attempted 2nd degree murder. This incident occurred in Okaloosa County where I am a duly sworn law enforcement officer.
