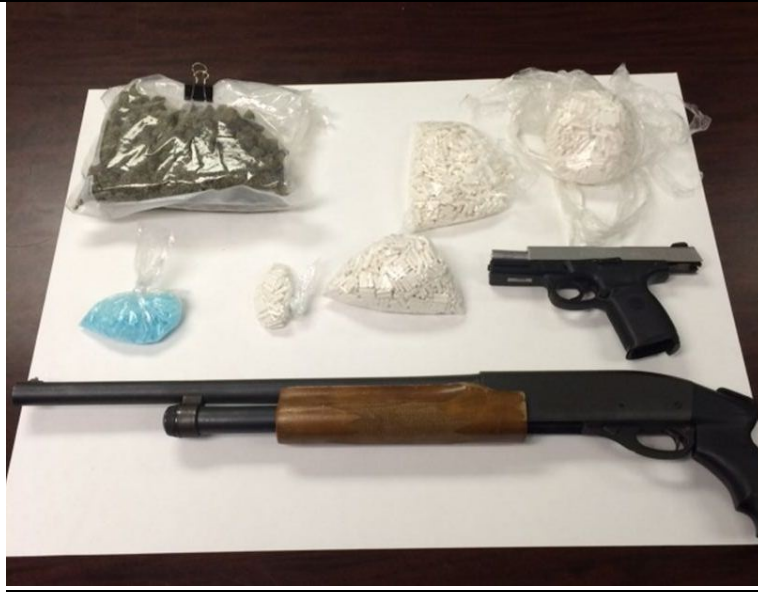

OCISO NARCOTICS UNIT ARRESTS THREE, SEIZES DRUGS, CASH AND VEHICLES



Three people were arrested and a large amount of drugs and cash were seized today following the execution of a search warrant at a Crestview home by members of the Okaloosa County Sheriff's Office Narcotics Unit.

34-year old Robert P. Wilcox and 30-year old Valerie A. Wilcox, both of 6118 Old Hickory Road, are charged with possession of a hallucinogen with intent to distribute, possession of marijuana with intent to distribute, trafficking in methamphetamine, trafficking in Hydrocodone, possession of a schedule IV controlled substance with intent to distribute, and possession of drug paraphernalia.

In addition to the large amount of drugs and paraphernalia located, approximately \$17,000 in cash was seized as well as a vehicle and two motorcycles.

A third person present during the search warrant, 33-year old Nickolas Weeks, was also arrested for possession of a firearm by convicted felon and Possession of drug paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 07, 2015, a lawful search warrant was executed at 6118 Old Hickory Road, Crestview, Florida. During the execution of the search warrant, the CO-DEFENDANT, Robert Wilcox, and the DEFENDANT, Valerie Wilcox was present inside of the residence. The DEFENDANT and CO-DEFENDANT are the only individuals that reside in this residence.

During a search of the residence, approximately forty-eight (48) grams of crystal methamphetamine, in excess of twenty grams of marijuana, approximately seven hundred thirty (730) grams of alprazolam tablets, approximately ten (10) grams of ecstasy, approximately seventeen (17) grams of hydrocodone, approximately one (1) gram of fentanyl, and seven (7) diazepam tablets, were located within the residence.

Investigators further located corner bags, marijuana bongs, jeweler's bags, and digital scales that were consistent with persons involved in the distribution of illegal narcotics.

The above mentioned items were confirmed to be such through presumptive positive field test results and/or identification through www.drugs.com.

Post Miranda, the DEFENDANT declined to provide a statement and she requested an attorney.

There is probable cause to believe, and your AFFIANT does believe, Valerie Wilcox knowingly violated Florida State Statutes 893.13.7a4; Possession of a hallucinogen (ecstasy) with intent to distribute, 893.13.7a4; Possession of marijuana with intent to distribute, 893.135.1f1; Trafficking in methamphetamine, 893.135.5; Trafficking in Hydrocodone, 893.13.1c2; Possession of a schedule IV controlled substance (Xanax) with intent to distribute, and F.S.S. 893.147 (1) possession of paraphernalia.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On May 07, 2015, a lawful search warrant was executed at 6118 Old Hickory Road, Crestview, Florida. During the execution of the search warrant, the DEFENDANT, Nickolas Weeks, was located on the front porch of the residence. Prior to the search warrant being executed, Investigator Fields observed the DEFENDANT enter/exit a camper trailer that was located in the front yard of the residence several times.

K9 Deputy Tim Patterson conducted a dog walk on the camper trailer utilizing his police K9 "Dax". K9 Deputy Patterson advised your AFFIANT that K9 "Dax" indicated a positive K9 alert on the camper trailer. During a search of the trailer, your AFFIANT located a glass methamphetamine smoking pipe and a Remington 870 shotgun that was loaded with twelve gauge shotgun rounds.

Post Miranda, the DEFENDANT stated he has been sleeping in the camper trailer and that he had personal belongings within the trailer. The DEFENDANT admitted ownership of the glass methamphetamine smoking pipe and to using it to smoke methamphetamine. The DEFENDANT further admitted to having knowledge that the shotgun was present in the trailer and he was able to identify the location the shotgun was found in. The DEFENDANT stated the owner of the trailer placed the shotgun there at an unknown date/time; however, he still stayed in the trailer over night with the shotgun being present.

Your AFFILIANT requested a criminal history on the DEFENDANT. It was determined that on 10/31/2000, the DEFENDANT was arrested for possession of controlled substance and on 12/05/2000 the DEFENDANT was convicted of that felony offense.

There is probable cause to believe, and your AFFILIANT does believe, Nickolas Weeks, knowingly violated Florida State Statutes 893.147; Possession of drug paraphernalia and 790.23.1a; Possession of firearm by convicted felon.
