TEENS IN STOLEN CAR SCREAM PROFANITIES AT ARRESTING DEPUTIES

An Okaloosa County deputy attempting to stop a car traveling an estimated 90 miles per hour in a 55 mile per hour zone on Highway 98 on Okaloosa Island November 14th says the teenage driver ultimately ran off the road and hit a fire hydrant and small tree in Destin after refusing to pull over during a brief pursuit. The 2004 Kia Optima car turned out to have been stolen from a home on Virginia Oak Court in Fort Walton Beach. The car was wrecked near the intersection of Kelly Street and Calhoun Avenue.

The driver later identified as 16 year old Raven Alexis Nunn of 123 Third Avenue, Fort Walton Beach, initially refused to give her name, age, or any other information, instead yelling profanities at deputies. She jerked away from deputies attempting to detain her. Inside the patrol car she began to kick the window with her feet.

Deputies received the same verbal abuse from the front seat passenger, identified as 16-year old Chasity Tipton of 800 Cardinal Street, F.W.B., who also told deputies she knew the car was stolen and did not care.

A third passenger, 19-year old Christopher Lessig of 2807 Bradford Place, F.W.B., says he also knew it was stolen and that they were driving to Destin Commons.

In addition, a 10-year old girl was also in the stolen vehicle.

Nunn is charged with grand theft auto, fleeing and eluding, no valid driver's license, and resisting without violence.

Tipton and Lessig are both charged with grand theft auto.

Prior to being arrested in Destin, deputies say Tipton had vandalized her home, causing more than 24-hundred dollars in damage to the contents and structure. She also stole items.

Tipton is charged with felony criminal mischief, probation violation, and threatening public servants in connection with that incident. While being transported to booking she threatened to shoot up the police department.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/14/2015, at approximately 1328 hours, Defendant, Ms. Chasity Ann Tipton, did have possession of a motor vehicle reported stolen on 11/13/2015, did flee and attempt to elude law enforcement in a marked patrol unit with emergency lights and siren activated, did resist without violence, and did operate a vehicle; e on the roadway without a valid license

I observed a blue in color KIA sedan traveling eastbound on Miracle Strip Parkway, Fort Walton Beach, Florida at a speed I visually estimated to be approximately 80 MPH in a 55 MPH zone. I heard a Doppler tone emitting from Stalker Radar #DS046346 which was consistent with my estimation. The counting unit indicated an initial speed of 90 MPH in a 55 MPH zone.

I caught up to the vehicle and initiated a traffic stop using my emergency lights and marked Okaloosa County Sheriff's Office vehicle. The vehicle a blue in color KIA failed to stop and continued eastbound on Miracle Strip Parkway. I initiated my emergency siren with my emergency lights. The vehicle still failed to stop and continued eastbound on Miracle Strip Parkway and entered into the City of Destin. The vehicle made an abrupt left turn through the westbound

lanes of US Hwy 98 and onto Calhoun Ave. At this time the vehicle accelerated to a speed visually estimated to be approximately 50 MPH in a 30 MPH zone. The vehicle continued northbound on Calhoun Ave and when approaching slower traffic, the vehicle swerved into the southbound lanes traveling northbound. The vehicle continued to accelerate erratically and failed to yield to emergency lights and siren. The vehicle reached the area of the intersection of Calhoun Ave and Kelly St, Destin, Florida. The vehicle attempted to brake hard and negotiate a right turn onto Kelly Street, but the driver lost control of the vehicle and traveled off the roadway onto the shoulder, striking and displacing a fire hydrant and striking a small tree and bushes.

All occupants of the vehicle were detained including the Defendant who was sitting in the front passenger seat. Defendant was detained by additional Deputies who arrived on scene. Defendant was uncooperative and cursing. Defendant eventually provided her name and date of birth, and she was identified as Ms. Tipton. Defendant when told she was in a stolen vehicle (Offense #15-14255), she admitted she knew it was stolen and did not care.

To wit: Defendant did violate F.S.S. 812.014 (2c6) Grand Theft Auto, when she took a vehicle which did not belong to her and she did not have permission to operate.

This violation occurred in the County of Okaloosa, in the State of Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On November 14, 2015 an investigation was conducted into a criminal mischief and theft which occurred at 800 Cardinal Street #5, Fort Walton Beach. The investigation revealed persons entered into the residence and vandalized the

interior of the residence, causing an estimated \$2410 amount of damage to the contents and structure. Also \$120 in items were stolen from the residence. On the cabinet in the kitchen was a hand written statement "I was in this bitch with my squad destroying yo shit just like you did mine." The defendant, Chasity Tipton, was developed as a suspect in this incident. Tipton lived in the residence and had ran away from home the day before. Tipton was placed under arrest for a separate incident and during transport, made spontaneous statements, talking with a co-defendant, and admitted to breaking into the damaged residence.

Based upon the physical evidence and information gathered during the investigation, I have probable cause to believe the defendant, Chasity Tipton, did enter into the victim's residence and intentionally damage the victim property with a damaged value of over \$1000 in violation of F.S.S. 806.13(1b3).

As a result of her arrest, and during the course of the defendant being transported to the Booking Office, the defendant did threaten to shoot up the Police Department. This threat occurred in the presence of two Okaloosa County deputies. I have probable cause to believe this is Corruption by Threat to a Public Official and is a violation of F.S.S. 838.021(1a).

A computer check and interview with family revealed the defendant was currently on probation with an 8:00 pm curfew. The defendant did violate the terms of her probation by absconding from her residence and remain at large past her 8:00 pm curfew on November 13th, 2015. This is in direct violation of F.S.S. 985.101(1d)

This incident did occur in the county of Okaloosa, State of Florida.

The vehicle a blue in color KIA failed to stop and continued eastbound on Miracle Strip Parkway. I initiated my emergency siren with my emergency lights. The vehicle still failed to stop and continued eastbound on Miracle Strip Parkway and entered into the City of Destin. The vehicle made an abrupt let turn through he westbound lanes of US Hwy 98 and onto Calhoun Ave. At this time the vehicle accelerated to a speed visually estimated to be approximately 50 MPH in a 30 MPH zone. The vehicle continued northbound on Calhoun Ave and when approaching slower traffic, the vehicle swerved into the southbound lanes traveling northbound. The vehicle continued to accelerate erratically and failed to yield to emergency lights and siren. The vehicle reached the area of the intersection of Calhoun Ave and Kelly St, Destin, Florida. The vehicle attempted to brake hard and negotiate a right turn onto Kelly St, but the driver lost control of the vehicle and traveled off the roadway onto the shoulder, striking and displacing a fire hydrant and striking a small tree and bushes.

All occupants of the vehicle were detained including the Defendant who was in the drivers seat, behind the drivers wheel. The defendant was the individual I observed driving as the vehicle passed me on Miracle Strip Parkway. Additional units arrived on scene and the defendant was ordered to exit the vehicle and I attempted to open the front drivers door. The door would not open and defendant stated it does not open. The defendant began to exit through the window and when I grabbed her arm she jerked her arm away and retreated back into the vehicle. Defendant was physically removed from the vehicle and when placed on the ground failed again to comply with instruction when ordered to place her arms behind her back. Defendant was eventually handcuffed but refused to give her name, age, or date of birth. Defendant would yell profanities but would not give information requested during a lawful investigation. She did so with the apparent intention to prevent identification of herself and to impede the investigation.

Defendant was later identified and determined she does not have a valid drivers license issued and never has. Defendant was advised of her Miranda Rights and later admitted she had no licenses and admitted she did not pull over because she was going to go to jail anyway. Defendant later admitted to taking the vehicle when interviewed by Deputy Putnam, case Deputy on the original vehicle theft (Offense #15-14255).

To wit: Defendant did violate F.S.S. 812.014 (2c6) Grand Theft Auto, when she took a vehicle which did not belong to her and she did not have permission to operate, violated F.S.S. 843.02, Resisting without Violence, when she failed to comply with commands, and jerked away from Deputies attempting to detain her. Defendant further violated F.S.S. 316.1935 (4a), Fleeing/Elude Law Enforcement, when she willfully and knowingly failed to stop when commanded to do so by the presence of emergency lights, siren and a clearly marked patrol vehicle, and F.S.S. 322.03, No Valid Drivers License, Never Issued, when she knowingly operated a vehicle on the roadway without a drivers license.

These violations occurred in the County of Okaloosa, in the State of Florida.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]
