## October 12, 2015 CRESTVIEW DRIVER FACING CHARGES AFTER WILD DRIVE



An Okaloosa County Sheriff's Office deputy's encounter with a reckless driver started when he had to slam on his brakes to avoid a crash after the man turned left directly in front of his car on P-J Adams Parkway in Crestview.

36-year old Edmundo Gamboa III of 419 Northview Lane is charged with fleeing and eluding with disregard to safety and driving with a suspended license, second offense.

The deputy was heading west on P-J Adams Parkway around 4:30 a.m. yesterday morning, October 11<sup>th</sup>, when a Chevy Colorado turned left directly into his path. The deputy had to hit his brakes to avoid a crash. The other driver quickly accelerated to nearly sixty miles an hour in a 45 mile per hour zone. The man then failed to stop when the deputy tried to pull him over and merged onto Antioch Road. He did a loop inside the parking lot of Addison Place Apartments and began speeding on Antioch Road at approximately 70 miles per hour. His truck fishtailed when he turned onto Wild Horse Drive.

During a search of the neighborhood, the truck was found parked at a home on Nirvana Drive. Gamboa was found hiding in an alcove near the front door. Gamboa admitted to driving and trying to get away from the deputy. He also admitted his driver's license was suspended.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/11/15 at approximately 0430 hours, Iwas traveling west bound on PJ Adams Parkway approaching the light at Wild Horse Drive (within Crestview, Florida). As I got close the light a grey 2009 Chevrolet Colorado bearing Florida tag 752MUD turned left (west bound) from Wild Horse Drive directly in the path of my marked Okaloosa County Sheriff's Office patrol SUV. The vehicle caused me to quickly administer the brakes of my vehicle to avoid a traffic crash. The vehicle quickly accelerated to a speed of 60 miles per hour in the posted 45 mile per hour zone. I attempted to initiate a traffic stop on PJ Adams near Crab Apple Avenue. The vehicle continued to drive on PJ Adams Parkway and merged onto Antioch Road. The vehicle failed to stop and turned into the Addison Place Apartments (900 Addison Place, Crestview, Florida) where it made a complete loop around the apartment complex returning to Antioch Road. The vehicle turned left (south) on Antioch Road and again accelerated at a high rate of speed. The vehicle was estimated to travel approximately 70 miles per hours in the posted 45 mile per hour zone. The vehicle speed was confirmed using my certified, radar at 71 miles per hour. The vehicle continued on PJ Adams Parkway until turning right (south) onto Wild Horse Drive. Upon making the turn onto Wild Horse Drive, the vehicle's rear wheels lost traction causing it to fish tail. The vehicle then continued south into the housing development on Wild Horse Drive at an estimated speed of 50 miles per hours.

During a search of the neighborhood, the vehicle was located parked at 132 Nirvana Drive. Upon searching the

After taking Gamboa into custody he admitted to operating the vehicle and willingly fleeing from law enforcement. Gamboa also admitted he was aware that his driver's license was suspended.

Based on the above facts, Edmundo Gamboa was placed under arrest for Fleeing Eluding Disregard Safety of Others per F.S.S. 316.1935(3)(a) and Driving While License Suspended or Revoked 2nd Conviction per F.S.S. 322.34(2)(b)
