<u>DESTIN NIGHTCLUB DISTURBANCE LEADS TO ARREST WHEN</u> MAN FIGHTS WITH DEPUTY



An Eglin Air Force Base resident faces multiple charges following a 4 a.m. disturbance Sunday at a Destin nightclub.

21-year old Kadontre Akeem Nelson is charged with battery on a law enforcement officer, resisting an officer with violence, and disorderly intoxication.

Deputies say Nelson was intoxicated and involved in an altercation inside Nightown at 140 Palmetto Drive. He was being escorted out of the building by doormen. An Okaloosa County Sheriff's Office deputy attempted to place him in handcuffs but Nelson continued fighting and yelling. The deputy had to take him to the ground. Nelson continued to fight and had to be tazed three times before the deputy could gain compliance.

At booking, Nelson said he remembered the deputy identifying himself to him. When asked why he continued to fight when he knew the person was a law enforcement officer, Nelson said he was very intoxicated and made a bad choice.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 10-11-2015 Kadontre Nelson committed Resisting Arrest with Violence, Battery on a Law Enforcement Officer and Disorderly Intoxication, at Nightown 140 Palmetto Drive, Destin, and Florida.

Nelson was being escorted out the front door by the doormen due to him being involved with an altercation in the club and intoxicated. Once Nelson was outside and being held by the doormen, I identified myself and attempted to place him in handcuffs. Once I got one handcuff on Nelson the doormen let Nelson go and he began to pull away from me. I told him to stop, but he refused and began to yell at me and say he was not going to be put in handcuffs. Due to Nelson not complying with commands I placed my right hand on Nelson's upper chest and my right leg behind his and took him to the ground. Once I got Nelson to the ground he grabbed my jacket and attempted to pull me into him. I was able to

remove his hand and flip him over on his stomach. Once Nelson was on his stomach I told him several times to give me his hands; however, he continued to refuse and continued to try and fight and get away. Due to Nelson refusing to cooperate I pulled my Taser X2 and placed it in the small of Nelson's back and discharged the Arc trigger. After the first Arc discharge I told Nelson to give me his hands again, but he refused again and was tased a second and third time. After the third time I tased Nelson I was able to get his right hand and place it in the handcuff.

Once Nelson was detained he was checked for injuries and declined EMS.

Post Miranda Nelson stated that he was very intoxicated and admitted to grabbing my jacket and trying to get away.

Based upon my investigation I believe Kadontre Nelson is in violation of Florida State Statute 856.011 Disorderly Intoxication, 843.01 Resisting an Officer with Violence, and 784.07.2b Battery on a Law Enforcement Officer. These offenses occurred in Okaloosa County, Florida, where I am a sworn law enforcement officer.
