#### **DEPUTIES NAB PROWLER AFTER MORNING CHASE**

Okaloosa County Sheriff's Office deputies chased a teen burglary suspect through woods and subdivisions after getting multiple reports of a prowler in the Garden City area north of Crestview this morning.

17-year old Bradley Keith Anderson is now charged with burglary, possession of burglary tools, armed trespassing, resisting arrest without violence, and criminal mischief.

The first report of a prowler came in around 4:42 a.m. on Sonny Lane when a homeowner noticed his motion detector light go off and looked outside. He spotted someone up against his window looking in. A video showed the individual trying to pry open a window. The homeowner confronted the prowler, who took off on foot.

A second call came in on Laurel Lane around 5:30 a.m. A female says a man opened her front door and came inside, but ran when he saw her.

Deputies searching the area spotted a male matching the suspect's description walking on Auburn Road around 8:25 a.m. The individual, later identified as Anderson, ran into the woods when he spotted them. A perimeter was set up and a K9 came in to help track the teen. Anderson jumped fences and ran through multiple backyards, even trying to get into a house in the Brownstone Estates subdivision to escape, however the door was locked. He was captured at 3348 Citrine Circle. Deputies say Anderson had a flashlight and was armed with a folding knife.

[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On the morning of October 17, 2015, Deputies responded to 6083 Sonny Lane (OCSO Offense #15-13071) and 6116 Laurel Lane (OCSO Offense #15-13073) in reference to reported burglaries to occupied dwellings. During the investigation of these two incidents, both reporting parties described a white male subject, wearing a grey hooded sweatshirt, either entering or being on their property during the early morning hours while it was still dark.

On October 17, 2015, at or about 0825 hours, Deputies R. Culbertson and R. Robinson attempted to make contact with a male subject, walking on Auburn Road near the intersection of Anchors Road, which is located in the area of the reported burglaries. The male was white and wearing a grey hooded sweatshirt, which matched the description from the burglaries earlier in the morning. However, the defendant, later identified as Bradley Keith Anderson, fled down Anchors Rd into the adjacent woods upon sight of Law Enforcement. A foot pursuit ensued, but we lost sight of Anderson near the intersection of Possum Ridge Rd. and Melissa Ln. After losing sight of Anderson a perimeter was established in an attempt to contain Anderson. Anderson was observed several times actively avoiding marked Sheriff's Office patrol vehicles and uniformed deputy sheriffs. He also ignored commands to stop and get on the ground.

T. Patterson and K9 Dex responded to the area of Possum Ridge Rd and Melissa Ln and initiated a track on Anderson. Patterson and Dex were able to track Anderson from the woods between Melissa Ln and Possum Ridge Rd into the Brownstone Estates sub-division.

While Anderson fled from Law Enforcement he entered the fenced back yards of several sperate residences to include: 3344 Citrine Circle, 3348 Citrine Circle, 3400 Melissa Lane and 6226 Lapis Lane. The fencing around the yards was evidence that the defendant was not allowed to enter and knew or should have known he was trespassing in those yards.

It should be noted while jumping over the fence into 3344 Citrine Circle Anderson caused an estimated \$200.00 damage to the fence by breaking some of the fence components.

It should be further noted while in the back yard of 6226 Lapis Lane, Anderson attempted to gain entry to the occupied residence through the back door, but was unable to due to it being locked.

Anderson was apprehended in the fenced back yard of the residence identified as 3348 Citrine Circle. Upon conducting a search incident to arrest of his person, Anderson was found to be in possession of a black handled folding knife and a silver LED flashlight. The defendant was a suspect in additional burglaries during the hours of darkness. The flashlight was an item needed to commit burglaries during the hours of darkness and as such, constituted a burglary tool.

Portions of this incident were witnessed by Okaloosa County Deputies, Kyle R. Cox, Sheila D. Colon, Michael M. Waldo, Bryan S. Heinz and Luis J. Santana.

Based upon my investigation, the witness statements, and evidence present, I have reason to believe and do believe the defendant, Bradley Keith Anderson committed the offenses of F.S.S. 843.02 Resisting Officer Without Violence, F.S.S. 806.13.1 (b1) Criminal Mischief, F.S.S. 810.03 (3)(a), Burglary to Occupied Dwelling, F.S.S. 810.09 (2)(c) Armed Trespassing, F.S.S. 810.06 Possession of Burglary Tools. These offenses occurred in Okaloosa County, Florida.
