## **TWO ARRESTED AFTER MAN DRIVING STOLEN CAR CRASHES INTO TREE**

Two brothers face multiple charges after the car they were in crashed into a tree while they were fleeing a deputy Sunday, October 18<sup>th</sup>, around 3 p.m. The car was later reported stolen.

A deputy attempted a traffic stop Sunday afternoon on a vehicle being operated by 24-year old Hale Kaleem Orr. Hale did not stop the vehicle, a Chevrolet Aveo, and instead fled at a high rate of speed. He lost control of the vehicle a few hundred feet down the roadway and slid into the bushes at the intersection of Rickey Avenue and Harris Road. When the deputy parked behind Orr to detain him, Orr put the car in reverse and hit the marked patrol car, causing minor damages to both vehicles. Orr then fled down Harris Road. He crashed into trees near the intersection with Washington Street. Orr and the passenger, 19-year old Sebastian Kaleb Orr, were then detained without further incident. They were transported to Fort Walton Beach Medical Center for treatment.

Sebastian Orr was found to be in possession of a loaded .22 caliber pistol and extra ammunition. He is charged with carrying a concealed weapon, possession of a weapon by a convicted felon and possession of marijuana.

The owner of the Chevy Aveo reported it stolen Sunday evening. She says Hale Orr only had permission to drive it to pick her up from work at 7 a.m. Sunday but never returned.

Hale Orr is charged with fleeing and eluding, driving with a suspended license, aggravated battery on a law enforcement officer, possession of a controlled substance with intent to distribute, possession of a controlled substance without a prescription, possession of marijuana, and possession of drug paraphernalia.

Additional charges are pending.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On October 18, 2015 I, Deputy Sheriff Petersen, was sitting in the middle turning lane of Eglin Parkway in front of 838 Eglin Parkway, Fort Walton Beach, Florida. I observed the driver, later identified as the defendant Hale Orr, of a small white 2004 Chevy Aveo with black rims traveling southbound on Eglin Parkway without a safety belt on.

I attempted to conduct a traffic stop on the vehicle by activating my emergency lights and sirens as the vehicle continued northbound on Rickey Avenue at approximately 30 miles per hour. The vehicle took evasive action by traveling at a high rate of speed. At the intersection of Rickey Avenue and Harris Boulevard the vehicle began sliding sideways as he lost control. I pulled in behind him with my emergency lights still activated and the defendant shifted his vehicle into reverse and struck my marked patrol vehicle. The defendant began fleeing westbound on Harris Boulevard at a high rate of speed as I followed with my emergency lights and siren activated. While approaching the intersection of Harris Boulevard and Washington Street the defendant crashed into a tree.

The defendant was detained and a search of his person revealed a small blue pack tucked into the defendants pants. The pack contained a small orange cylinder bottle, a small metal cigarette shaped pipe with marijuana in it, and small plastic bags. The cylinder contained thirteen green pills, identified as Clonazepam (Schedule IV Prescription Narcotic), a bag containing a white powdery substance and approximately five grams of a green leafy substance. The white powdery substance field tested positive for cocaine and the green leafy substance field tested positive for THC. Inside the vehicle was a small cigar filled with a green leafy substance which also field tested positive for THC. The 13 Clonazepam pills were wrapped in the same bags found in the blue pack and appeared to be used to distribute the pills.

Based on the above information I have reason to believe and do believe the defendant, Hale Orr, violated Florida State Statutes 316.1935.3a Fleeing and Eluding, 322.34.2a Driving While License Suspended/Revoked, 784.07.2d Aggravated Battery on a LEO, 893.13.1a2 Possession with Intent to Distribute Controlled Substance Clonazepam, 893.13.6a Possession of a Controlled Substance without a Prescription, 893.13.6b Possession of Marijuana under 20 grams, and 893.147.1 Possession of Drug Paraphernalia. This incident occurred in Okaloosa County where I am a sworn Law Enforcement Officer.

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On October 18, 2015 I, Deputy Sheriff Petersen, was sitting in the middle turning lane of Eglin Parkway in front of 838 Eglin Parkway, Fort Walton Beach, Florida. I observed the driver of a small white 2004 Chevy Aveo with black rims traveling southbound on Eglin Parkway without a safety belt on.

The driver began fleeing and ultimately crashed at the intersection of Harris Boulevard and Washington Boulevard where he and the passenger, the defendant Sebastian Orr, were detained. While searching the defendant's person a small baggy containing six .22 caliber bullets was discovered in his right pants pocket. The defendant stated the driver may have a firearm. A search of the vehicle revealed a small revolver pistol concealed under a yellow bag within the reach of the defendant on the back floor board. Also discovered was a small cigar, containing a green leafy substance which field tested positive for THC, in an ash tray next to the defendant. Further investigation revealed the defendant
